#### **Terms of Assessment**

The scope of the evaluation is to verify compliance with Havisual Sawmill Sdn. Bhd. (Goodvision Trading Sdn. Bhd.) to the criteria within the Sabah Timber Legality Assurance System (TLAS) Principle 5 - Mill Operations and Principle 6 - Trade and Customs standards. Compliance is defined when the organization demonstrates that there is no non-compliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

#### **Limitations of Assessment**

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. Auditor's reporting of information presented by the client is taken as accurate unless evaluated differently through the observations made during the assessment. ## **Background Information:**

Havisual Sawmill Sdn. Bhd. (Havisual Sawmill) is, on and from 02/11/1996, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Malaysia, with registration #: 199601036287 (408640-V).

Goodvision Trading Sdn. Bhd. (Goodvision Trading) is, on and from 31/03/2008, incorporated under Companies Act 2016, and is registered in Kuala Lumpur, Malaysia, with registration #: 200801010511 (0811799-X). Goodvision Trading is the sister company of Shinn FA Lumber Co. Ltd., a Taiwan-based company.

Havisual Sawmill (Landlord) has a tenancy agreement with Goodvision Trading (Tenant) and is valid through 31/03/2025. Havisual Sawmill is a beneficial landowner at CL075449008, Sungai Seguntor, Off Mile 11, Jalan Labuk, 90000 Sandakan, Sabah. The Landlord is responsible for paying licensing regarding the sawmill. The Tenant produces sawn timber for the local market and exports them to Taiwan.

## **Associated Organizations & Subcontractors:**

Goodvision Trading does not engage other company as their subcontractors to provide sawmilling services or manpower and manufacturing products.

#### Recommendations

Havisual Sawmill Sdn. Bhd. (Goodvision Trading Sdn. Bhd.) has demonstrated compliance with the Sabah Standard Principles 5-6 for Chain of Custody and is recommended to receive a GFS Statement of Compliance and Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

**Gap 001/2024 (minor) – Checklist 5.3.6, 5.3.8:** Goodvision Trading shall address issues raised by DOSH by providing work safety training (Noise exposure) and fire training annually and maintain training records, such as attendance sheet.

**Observation 001-2024 – Checklist 5.1.3, 5.2.8:** Havisual Sawmill should record the sawn timber carry forward for Appendix 1 online submission and log supply correctly.

Observation 002-2024 – Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3, 6.1.4: Goodvision Trading shall implement purchasing according to the CoC procedure.

**Observation 003-2024 – Checklist 5.3.5:** Goodvision Trading should register all workers with PERKESO as stipulated in the PERKESO requirement.

The next surveillance visit is scheduled for October 2025.
