Terms of Assessment

Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Seratim Sdn. Bhd. (Seratim) is, on and from 08/05/1987, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Malaysia, with registration #: 198701002683 (0161355-X). Seratim has a warehouse for storing sawn timber and exports them to Belgium and United Kingdom. Seratim is also FSC-certified, FSC #: FSC-C124437 (SGSHK-COC-450014), with an expiry date of 16/02/2025 & has a valid PEFC-certified PEFC #: PSV-PEFC-COC-101098, with an expiry date of 14/09/2027.

Prosper Timber & Hardware Sdn. Bhd. (sister company by Seratim Sdn. Bhd.) has an agreement dated 16/06/2021 with SRT Timber to receive, handle and store sawn timber at their warehouse (Glory Yard).

Seratim does not engage subcontractor to produce, manufacture products or provide manpower.
