Compliance is defined when the organization demonstrates that there is no non-compliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Tawau Kilning & Moulding produces sawn timber and moulded timber for the local market and exports to Taiwan, Japan, South Korea, Canada and The United States of America. The company also provides kiln-dry services to their clients.

The previous assessment was conducted in June 2022 that resulted in 2 gap(s) and 2 observation(s) (Report #: GFSSBH 004-355).
