Bonusoon Trading (formerly known as Bonusoon Wood) has a tenancy agreement with Tropical Timber & Trading (Sabah) Sdn. Bhd. to operate the warehouse from 01/01/2023 to 31/12/2028.

The previous assessment was conducted in January 2023 that resulted in 1 gap(s) and 2 observation(s) (Report #: GFSSBH 004-448).

Bonusoon Trading subcontracts Cymasun Trading Sdn. Bhd. for resizing services based on buyer's orders / specifications. Bonusoon Trading shares warehousing facilities with Cymasun Trading Sdn. Bhd. Bonusoon Trading engages Jelas Cermat Sdn. Bhd. as a subcontractor to provide manpower.
