Tropical Timber & Trading (Sabah) Sdn. Bhd. [Tropical Timber & Trading (Sabah)] is, on and from 05/12/1983, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Malaysia, with registration #: 198301015783 (111175-A). Tropical Timber & Trading (Sabah) has no operations since 2019.

Bonusoon Wood Sdn. Bhd. (Bonusoon Wood) is, on and from 31/12/1996, incorporated under Companies Act 2016, and is registered in Kuching, Malaysia, with registration #: 199601043082 (415435-T). The company changed its name to Bonusoon Trading Sdn. Bhd. (Bonusoon Trading) on 28/07/2023. Bonusoon Trading imports plywood and sawn timber and sells them to the local market. The company also purchases doors from the local market and sells them locally.

A Tenancy Agreement was made on 01/01/2023 between Tropical Timber & Trading (Sabah) (Landlord) and Bonusoon Trading (Tenant).

Associated Organizations & Subcontractors:

Bonusoon Trading has a "Memo of Work Service" with Cymasun Trading Sdn. Bhd. for providing work service. Jelas Cermat provides manpower to Bonusoon Trading and Cymasun.
