Gap 003/2023 (minor) – Checklist 5.2.5 & 5.2.7: Perusahaan Kosinar shall implement the identification of batch number and segregation of Sabah TLAS and non-Sabah TLAS materials from logs received to finished goods.

Observation 001-2023 – Checklist 5.1.2: Perusahaan Kosinar shall be consistent in recording Appendix C.

The next surveillance visit is scheduled for September 2024.
