Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Soonlinmas Sdn. Bhd. (Soonlinmas) is registered in Sarawak, Malaysia, with registration # 199401022491 (308176-A). Soonlinmas imports plywood and blockboard from Indonesia & Vietnam for the local market.

Soonlinmas has a tenancy agreement between Tropical Timber & Trading (Sabah) Sdn. Bhd. from 1st February 2023 to 31st January 2025.

The previous assessment was conducted in February 2024 that resulted in 3 gap(s) and 1 observation(s) (Report #: GFSSBH 004-465).

Associated Organizations & Subcontractors:

Soonlinmas engages Bonusoon Trading Sdn. Bhd. to provide manpower as part of the warehouse tenancy agreement between Tropical Timber & Trading (Sabah) Sdn. Bhd. Bonusoon Trading engages Jelas Cermat Sdn. Bhd. as a subcontractor to provide manpower. Soonlinmas shares warehousing with Bonusoon Trading and Cymasun Trading.
