Gap 002/2024 (minor) – Checklist 5.2.11, 5.2.12: SG Trading shall ensure that the current production system is in accordance with the COC procedure to ensure traceability from materials receiving to finished goods.

Observation 001-2024 – Checklist 5.1.3, 5.2.8: SG Trading shall record carry forward stock for Appendix 7 online submission and record the sawn timber supply volume in Appendix 7 manual correctly.

The next surveillance visit is scheduled for May 2025.
