Gap 002/2025 (minor) - Checklist 5.1.3: Kinabalu Supreme should ensure that the data entries for log supply and sawn timber are accurately recorded. It is also recommended that HQ provide a proper calculation for the discrepancies and carry forward log stocks.

Gap 003/2025 (minor) - Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3: Kinabalu Supreme shall ensure the purchasing is according to the CoC procedure.

Gap 004/2025 (minor) – Checklist 5.3.6: Work safety training should be conducted annually. Observation 001-2025 – Checklist 5.3.2: Kinabalu Supreme should ensure permits are available.

The next surveillance visit is scheduled for April 2026.
