Gap 002/2025 (minor) - Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3: Pemborong PKS should use a Purchase order for purchasing of logs as per the CoC procedure.

Gap 003/2025 (minor) – Checklist 5.3.1, 5.3.2: Workers should have employment agreements. Gap 004/2025 (minor) – Checklist 5.3.5: Pemborong PKS should seek guidance from KWSP/SOCSO regarding workers registration and contribution.

Observation 001-2025 - Checklist 5.3.6: Training records should include date of training and participants.
