**Observation 001-2024 – Checklist 5.1.3:** Sogoraya shall ensure that the recording of output of Appendix 7 online and manual is consistent.

Observation 002-2024 – Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3, 6.1.4: Sogoraya should be consistent in using a Purchase Order and record the Purchase Order in the arrival book.

The next surveillance visit is scheduled for September 2025.
