Terms of Assessment

The scope of the evaluation is to verify compliance of Bountiful Returns Sdn. Bhd. (Sukses Jadi Sdn. Bhd.) to the criteria within the Sabah Timber Legality Assurance System (TLAS) Principle 5 - Mill Operations and Principle 6 - Trade and Customs standards. Compliance is defined when the organization demonstrates that there is no non-compliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Limitations of Assessment

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. Auditor's reporting of information presented by the client are taken as accurate, unless evaluated differently through the observations made during the assessment. All information presented in the report is accurate and complete to the best of knowledge of GFS.

Background Information:

Bountiful Returns Sdn. Bhd. (Bountiful Returns) is registered in Kuala Lumpur, Malaysia, with registration # 285076-W. Sukses Jadi Sdn. Bhd. (Sukses Jadi) is registered in Tawau, with registration # 1060600-M.

Sukses Jadi (Tenant) has a tenancy agreement with Bountiful Returns (Landlord) to operate the veneer / plywood mill and sawmill from 01/12/2021 to 30/11/2023. Sukses Jadi produces veneer for the local market and exports them to India, Taiwan, The Philippines, and Peninsular Malaysia. Sukses Jadi operates the sawmill for internal use only.

The previous assessment was conducted in December 2022 that resulted in 1 gap(s) and 1 observation(s) (Report #: GFSSBH 004-434).

Sukses Jadi does not engage other organizations or subcontractors to provide or manufacture products.
