Terms of Assessment

Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. Auditor's reporting of information presented by the client is taken as accurate unless evaluated differently through the observations made during the assessment. Background Information:

MCBIO Sabah Sdn. Bhd. (MCBIO Sabah) is, on and from 15/08/2019, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Sabah, Malaysia, with registration # 201901029099 (1338428-H). MCBIO Sabah began receiving raw materials in May 2024 and initiated a trial production from October 2024 onwards by producing wood pellets and intends to export them to Japan.

Associated Organizations & Subcontractors:

MCBIO Sabah does not engage subcontractor to produce, manufacture products or provide manpower.
