Summary Information

Overview of Licensee:

Rakyat Berjaya Sdn. Bhd. (Rakyat Berjaya) as a subsidiary of Innoprise Corporation Sdn. Bhd., a whollyowned subsidiary of Yayasan Sabah (Yayasan Sabah) and one of the Yayasan Sabah Group of Companies, was incorporated in 1970. Rakyat Berjaya has been set up to undertake and manage the Yayasan Sabah concession area under a Sustainable Forest Management License Agreement (SFMLA). The SFMLA 09/97 was signed on 10th September 1997 between the Government of the State of Sabah and Yayasan Sabah. This SFMLA superseded the original Principle License Agreement for Timber #: COLK 1/70, issued in 1970. The new SFMLA has provided provision for planting forest or timber trees in the licensed area.

Rakyat Berjaya has appointed six (6) contractors namely Hasrat Gagah Sdn. Bhd., Focus Lumber Berhad, Kinsasynergy Sdn. Bhd., Tetap Jadi Sdn. Bhd., Primarth Sdn. Bhd. and Luasong Plantation Sdn. Bhd. inside the licensed area of FMU 15.

Hasrat Gagah engages its sister company, Cargo Timber to provide manpower.

Kinsasynergy engages its sister company, Eko Jutamas Sdn. Bhd. to provide manpower.

Coupe permit, KGU 09/2022 (Ref. #: JPHTN/FRM/700-2/1/09/116/1/13, dated 17/08/2022), has been issued to Pusat Kraftangan Sabah (PKS) as Community Forestry Compartment (CFC) to manage 79.80 ha of the area within the Yayasan Sabah Concession (YK1/2021) to plant Bamboo and Rattan. This project is called Program Penanaman Bahan Mentah (PPBM) and was funded by Program Khas Anak Negeri (PKAN) Rancangan Malaysia ke-12 (RMK-12: 2021 – 2025) to ensure the sustainability of raw material for handicraft products.

Environmental Context:

FMU 15 has been logged several times using conventional techniques over the past 30 years thus is considered a degraded secondary forest area.

The common species in the entire area of the proposed project area consists of primary/secondary forest and riparian vegetation include "Legub" (*Orthiopteris kingil*), "Melapi" (*Koompasia spp.*), "Mahang" (*Macaranga wray*), "Keruing" (*Dipterocarpus* spp.), "Randagong" (*Trema orientelis*), "Selangan" (*Shorea* spp.), "Resak" (*Cotyleloblum* spp.), "Pengiran" (*Anisoptera* spp.), "Kayu Malam Gajah" (*Diospyros discocalyx*), "Gapis" (*Saraca eclinate*), "Katong Katong" (*Cynoptera inaequifolia*), Tetiup (*Axinandra borneensis*), "Tinjau" (*Gnetum leptostachyam*), "Pakudita" (*Alphitomia incana*), "Kelat" (*Eugenia* spp.), "Medang" (*Dehaasia* sp.), "Kapur" (*Dryobalanops* spp.), "Mallotus" (*Mallotus korthalsil*), "Senduduk" (*Melastoma* sp.), "Rumput Siam" (*Eupotarium odoratum*), "Lalang" (*Imperate cylindrica*), "Seraya" (*Shorea* spp.), "Pelajau" (*Pentaspadon Motley*), "Gangulang" (*Blumeodendron tokbral*) and "Resam" (*Dicranopteris linearis*). Based on site survey, there is 1 protected floral species, namely "Polod" (*Arenga undulatifolia*) recorded within the project site.

Some common species of faunal reported to be present within the project area include Field Rat (*Rattus tiomanicus*), Squirrel (*Callosciurus notatus*), Barking Deer (*Muntiacus muntjac*), Bearded Pig (*Sus barbatus*), "Musang" (*Hemigalus derbyanus*), Hornbill (*Buceros rhinoceros*), Spiderhunter (*Arachnothera sp.*), Pigeon (*Treron sp.*), Swallow (*Hirundo tahitica*), Flycatcher (*Cyornis spp.*), Brown Wood-Owl (*Strix leptogrammica*), Forest Stream Frog (*Rana spp.*), Tree Frog (*Polypedates spp. & Rhacophorus sp.*), Snake (*Elaphe spp.*) and Skinks (*Mabuya multifasciata & Riopa bowrinngi*).

The faunal species can adapt to the disturbed primary/secondary forest. They can also move elsewhere in the surrounding area while the project activities are being cared out. However, all faunal species should be protected from any illegal hunting activities and encroachment/disturbance of their natural habitat (corridor of riparian reserve).

Tetap Jadi: Proposed Logging Operation of Block YK1/2023 and YK2/2023 (5,000 Hectares) Within FMU 15 of Yayasan Sabah Concession Area at Sungai Pinangah Forest Forest Reserve in Sook, Sabah [Ref. #: JPAS/PP/SOOK/600-1/01/1/350 (26) dated 14/05/2024].

Kinsasynergy: Proposed Logging Operation of 2,000 Hectares Within Yayasan Sabah Concession Area Under Forest Management Unit 15 in Tongod, Sabah (Ref. #: JPAS/PP/TGD/600-1/01/1/346 (26) dated 10/11/2023).

Hasrat Gagah: Logging Operation in Block YK6/2023(A) (1,067 Hectares) and Block YK6/2023(B) (3,836 Hectares) at Sungai Pinangah Forest Reserve within Yayasan Sabah Concession Area, District of Tongod, Sabah (Ref. #: JPAS/WPD/TGD/900-1/01/1/2 (16) dated 21/06/2024).

- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not comply adequately with a criterion.

Rakyat Berjaya Sdn. Bhd. has not complied with the Sabah TLAS requirements (FDS TLAS-006) as non-compliance was identified under criteria 1.6 & 1.7 during the assessment on 16-20 December 2024.

Summary of status of operations by **Principle**:

Principle 1. Right to Harvest

The SFMLA 09/97 was awarded by the State Government to Sabah Foundation (Yayasan Sabah) on 10/09/1997 to manage the forest area for 100 years until 09/09/2097.

December 2024: Gap 001/2024 (minor) – Checklist 1.2.5

No evidence of the ECR has been conducted under Kinsasynergy from July to November 2024.

December 2024: Gap 002/2024 – Checklist 1.3.2.2

The forest quality defined in the 2nd FMP differs from the SFD standard for forest stratification and lacked the list of compartments under each stratum in relation to management planning for ITP and NFM.

December 2024: Gap 003/2024 (minor) - Checklist 1.3.2.7

NFM harvest schedule of logging all 39 compartments within 4 years is not based on Sustainable Natural Forest Management systems but reflects typical logging systems.

December 2024: Gap 004/2024 (Major) - Checklist 1.6.4, 1.6.5, 1.6.6, 1.7.4

Lack of evidence of CPP development for the ITP areas under current salvage logging and planned for planting.

February 2025: Gap 004/2024 (Major) – Closed

CPPs for compartments 28, 34, 35, 45, 46, 48, 49, 50, 53, and 45 were submitted to SFD on 14 Feb 2025.

February 2025: Observation 001-2025 - Checklist 1.6.6

The submitted CPPs are pending approval by the SFD.

December 2024: Observation 001-2024 – Checklist 1.7.1

Inconsistent marking on the coupe boundary for KGU.03/2024.

December 2024: Observation 002-2024 – Checklist 1.7.3

No signage and inconsistent paint for ground identification on the steep area for KGU.03/2024.

Principle 2. Forest Operations

No evidence of disturbance in the protected areas was observed during the field assessment.

December 2024: Gap 005/2024 (minor) – Checklist 2.1.1

Excessive blading observed at Compartment 210, SKT 24.

December 2024: Gap 006/2024 (minor) – Checklist 2.3.3

PSP has not been established and analysed under ITP and NFM land use.

No safety training specific to job functions was conducted by contractors, and PPE distribution records were inconsistent.

Principle 3. Statutory Charges

Rakyat Berjaya has paid the applicable licensing fees and other charges to the SFD.

Expired OP and pending OP payment under Kinsasynergy.

Principle 4. Other User Rights

Based on the 2nd FMP and EIA, all local settlements are outside the licensed area. According to the EIA, there are no claims or areas used by the local communities, and no significant impacts to the communities have been identified. Potential impacts identified are associated with the river use by communities that may be affected through siltation by logging activities. Mitigation is through protection of buffer zones for streams.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

Gap 001/2024 (minor) – Checklist 1.2.5: The ECR for Kinsasynergy shall be conducted every 4 months as required by EPD.

Gap 002/2024 (minor) – Checklist 1.3.2.2: The forest quality defined in the 2nd FMP shall be in accordance with the SFD standard for forest stratification associated with a list of compartments under each stratum that justifies management planning for ITP and NFM.

Gap 003/2024 (minor) – Checklist 1.3.2.7: NFM harvest schedule should be based on Sustainable Natural Forest Management systems with Annual Allowable Cut over a defined harvest cycle.

Gap 005/2024 (minor) – Checklist 2.1.1: Rakyat Berjaya shall strictly monitor all RIL harvesting operation that is based on the RIL guideline.

Gap 006/2024 (minor) – Checklist 2.3.3: Rakyat Berjaya shall establish the PSP and conduct the analysis for the ITP and NFM land use.

Gap 007/2024 (minor) – Checklist 2.4.5, 2.4.6: All contractors shall conduct safety training based on job function for workers and record PPE distribution consistently.

Gap 008/2024 (minor) – Checklist 3.1.1: Kinsasynergy shall pay the OP and OP should be renewed three months before the expiry date.

Observation 001-2024 - Checklist 1.7.1: Marking of the coupe boundary for KGU.03/2024 should be clearly defined.

Observation 002-2024 - Checklist 1.7.3: Signage and marking on the ground for the steep area for KGU.03/2024 should be clear.

Observation 003-2024 - Checklist 2.3.5: Rakyat Berjaya shall conduct the forest fire awareness programme as required.

Observation 004-2024 - Checklist 2.4.1, 2.4.2: Eko Jutamas shall register workers for COI as required.

Observation 001-2025 – Checklist 1.6.6: SFD should expedite the approval process for the submitted CPP.

The next annual surveillance audit will be scheduled for **December 2025**.
