Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Hevajaya Sdn. Bhd. (Hevajaya) is registered under SSM, with registration # 458929-H. Hevajaya produces sawn timber, sold them locally and exports them to South Korea, Taiwan and Japan.

Hap Seng Property Investment has leased the mill and equipment to Hevajaya from 01/09/2020 to 31/08/2023. The renewal of the rental agreement is currently under review.

The previous assessment was conducted in December 2022 that resulted in 1 gap(s) and 0 observation(s) (Report #: GFSSBH 004-439).
