Lamitech International has participated in the PEFC with certificate #: SIRIM-COC 00224, valid until 20 August 2024. The company produces and exports moulding products mainly to Singapore, Germany, Japan, and South Korea.

Lamitech International has a tenancy agreement dated 06/01/2023 with Lamitech Wood Industries for six months or such extended period as shall be mutually agreed by the parties herein. Lamitech Wood Industries responsible in complying with the Malaysian Act Law for its employees and permitted to utilize Lamitech International's license.

The previous assessment was conducted in July 2022 that resulted in 1 gap(s) and 0 observation(s) (Report #: GFSSBH 004-369).

#### **Associated Organizations & Subcontractors:**

Lamitech International engages Bidasari Sdn. Bhd. to provide kilning services and RM Services as a subcontractor for handling import & export activities. Lamitech International engaged Agensi Pekerjaan Decaria Sdn. Bhd. as their agent to handle passports and work permits for foreign workers.
