Gap 003/2024 (minor) – Checklist 5.2.2: SFD shall be consistent in stamping the removal pass with the Sabah TLAS CC stamp.

Gap 004/2024 (minor) – Checklist 5.2.5, 5.2.7: Taman Timber Enterprise shall correctly identify Sabah TLAS status on WIP & Finished Goods.

The next surveillance visit is scheduled for April 2025.
