Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Ameron Wood Sdn. Bhd. (Ameron Wood) is registered in Kuala Lumpur, Malaysia, on 01/12/2016 with registration # 1210968-W. The company produces and trades sawn timber for the local market and exports to China.

Hap Seng Property Investment rents Sawmill A to Ameron Wood Sdn. Bhd. from 01/11/2020 to 31/10/2023 for sawn timber production.

The previous assessment was conducted in September 2021 that resulted in 3 gap(s) and 2 observation(s) (Report #: GFSSBH 004-239).

Recommendations

Ameron Wood Sdn. Bhd. / Hap Seng Property Investment Sdn. Bhd. has now demonstrated compliance with the Sabah Standard Principles 5-6 for Chain of Custody as non-compliance was addressed in criterion 5.3 and is recommended to receive a GFS Statement of Compliance or Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

Gap 002/2021 (Minor) Outstanding – Checklist 5.2.5, 5.2.7: The company shall consistently identify batch numbers & Sabah TLAS Status on WIP materials and inished goods as per the COC manual. Gap 003/2021 (Minor) Outstanding – Checklist 5.3.2, 5.3.7: Conduct and record safety training annually and ensure all workers are wearing appropriate PPE in the mill.

Gap 002/2022 (Minor) – Checklist 5.3.4: Submit the JKKP 8 to DOSH annually as required.

The next surveillance visit is scheduled for September 2023.
