Compliance is defined when the organization demonstrates that there is no noncompliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. Auditor's reporting of information presented by the client are taken as accurate, unless evaluated differently through the observations made during the assessment. All information presented in the report is accurate and complete to the best of knowledge of GFS.

Background Information:

Hap Seng Property Investment Sdn. Bhd. (Hap Seng Property Investment) is registered in Kuala Lumpur, Malaysia, with registration # 183641-A. CBS Products is registered in Miri, Malaysia, with registration # 798928-U. CBS Products produces briquette charcoal to the local market and exports them to Japan.

CBS Products rents premises from Hap Seng Property Investment (Shed 91/92) from 01/11/2021 to 31/10/2024.

The previous assessment was conducted in November 2022 that resulted in 0 gap(s) and 1 observation(s) (Report #: GFSSBH 004-423).

CBS Products does not engage other companies as their subcontractors to provide or manufacture products.

Highlights of Close-Out Visit (if applicable) Date: 11 January 2024

CBS Products provided the removal pass for the waste wood and identified the CoC code & status on WIP and finished goods and closed the Major gaps 002/2023 & 004/2023. However, CBS Products did not renew the JTK license and workers were not registered under SOCSO. Thus, Major gap 005/2023 remains outstanding.

Recommendations

CBS Products Sdn. Bhd. has not demonstrated compliance with the Sabah Principles 5-6 for Chain of Custody as non-compliance was identified under Criteria 5.2, 5.3 and is NOT recommended to receive a GFS Statement of Compliance or Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

The Major Gap shall be addressed within two months by January 2024.

Gap 005/2023 (Major) Outstanding – Checklist 5.3.1, 5.3.5: CBS Products shall register all workers and contribute under SOCSO as required and ensure the JTK license to hire foreign workers is valid.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

Gap 001/2023 (minor) – Checklist 5.1.1: The mill shall renew the license 3 months before the expiry date and the SFD shall expedite the license approval for the mill to proceed with payment.

Gap 003/2023 (minor) – Checklist 5.2.3: CBS Products shall identify Sabah TLAS status in the material arrival book.

Gap 006/2023 (minor) – Checklist 5.3.2, 5.3.7, 5.3.8: CBS Products shall conduct safety and fire training for workers annually. Fire extinguishers shall be valid with pressure within the mill.

Observation 001-2022 (Outstanding) – Checklist 5.3.3, 5.3.6: CBS Products should rectify outstanding issues raised by DOSH.

The next surveillance visit is scheduled for November 2024.
