Gap 001/2024 (minor) – Checklist 5.2.11: WIP should be identified with a batch number and status from receiving to the Finished Goods as per the CoC procedure.

Gap 002/2024 (minor) – Checklist 5.3.6, 5.3.7: Ameron Wood shall conduct the work safety training annually, display safety signages and establish the PPE distribution record.

Gap 003/2024 (minor) – Checklist 6.1.5: Sabah TLAS Compliance Certificate number and Sabah TLAS status should be clearly identified on Sales invoice and packing list.

Observation 001-2024 – Checklist 5.3.2, 5.3.3: Ameron Wood should provide employment agreements to workers.

The next surveillance visit is scheduled for December 2025.
