Summary Information

Overview of Licensee:

Rakyat Berjaya Sdn. Bhd. (Rakyat Berjaya) was appointed in 1970 to manage FMU 23, in which the licensed area is located along with the 7 other Forest Management Units (FMUs), which make up the Yayasan Sabah Concession Area.

Rakyat Berjaya obtained a license to manage FMU 23, where operations focus mainly on harvesting (Natural Forest Management), planting (harvesting / clearing of degraded forests followed by planting - Mosaic ITP areas) and oil palm (Agroforestry).

Land tenure is based on:

- The Sustainable Forest Management Licensed Agreement (SFMLA) 09/1997 commenced on 10 September 1997 with a 100-year tenure which will expire on 10 September 2097.
- A supplementary agreement to reduce the Yayasan Sabah Concession Area from 799,828 ha to 599,828 ha was signed on 15 February 1999.
- Tree Plantation and Forest Management Agreement JP(TKA)122/96(CO) 24 April 1996 106,310 ha and Supplemental Agreement JP(TKA)122/96(CO) 200,000 ha 15 February 1999 for NFM and tree planting under Benta Wawasan Sdn. Bhd.

Empayar Kejora Sdn. Bhd. (Empayar Kejora) is the appointed contractor to carry out residual timber extraction and develop a mosaic-planting scheme within the licensed area in FMU 23 located within the Gunung Rara Forest Reserve.

Empayar Kejora is also affiliated with Zillion Fortune Sdn. Bhd., Pesona Majukaya Sdn. Bhd., First Greenworld Sdn. Bhd. & Top Quantum Sdn. Bhd., which comes under the auspices of Rakan Rimba Sdn. Bhd.

The integrated mosaic tree planting system is implemented to ensure sustainable timber production by planting fast-growing indigenous and exotic species for the production of high-volume timber.

As of the assessment, Empayar Kejora has yet to appoint subcontractors for logging and planting.

Currently, Empayar Kejora only focusing on silviculture activities that includes climber cutting and weeding.

Environmental Context:

The area is logged over mixed highland dipterocarp forest consisting of Dipterocarps, such as Urat mata, Seraya kuning, Seraya merah, Keruing and Oba suluk and, other lesser-known species, such as Laran, Pelawan-Pelawan, Mempening, Medang, Keranji, Magas, Rengas, etc.

The altitude varies between 100m to 900m a.s.l

The nearest forest reserve is Imbak Canyon Conservation Area (Class I) in the west, Sg. Imbak Forest Reserve (Class VI) in the north, Sg. Pinangah Forest Reserve (Class II) in the northwest, and Kuamut Forest Reserve (Class II) in the northeast.

The mean annual rainfall recorded in 2009 until 2011 is 3,171.10mm with an average of 264.25mm/month.

The main rivers located the licensed area are:

- The main rivers located in the licensed area are Sg. Kuamut and its tributaries, which flow towards Sg. Kinabatangan.

The project area is underlain by Lokan Association. The major soil type is the acidic and nutrient poor Orthic acrisols.

Terrestrial mammals commonly sighted are Sambar deer, Borneon yellow muntjac, Bearded pig, Malayan civet, Common palm civet, Long-tailed macaque and Leopard cat. Avian species identified through calls and sightings: Great argus, Plaintive cuckoo and Crested serpent eagle. The biggest threat to wildlife in the licensed area is poaching.

Significant impacts:

- Soil erosion exacerbated by topography and conventional logging.
- Water quality deterioration.

- Refugia disturbance.

Ease of ignition due to increase in fuel loads (logging residue).

The EIA study titled "EIA for Proposed Integrated Mosaic Planting in Block YT1/12 of Yayasan Sabah Concession area in Tawau, Sabah." was prepared and approved by the EPD [Ref. #: JPAS/PP/21/600 1/01/3/47(48) dated 26/07/2012].

Social Context:

Based on 2nd FMP, there are no villages or human settlements within the FMU. The surrounding area is gazetted as Forest Reserve. Based on GFS observation, the nearest settlement is located 50 KM away from the licensed area, which is the Luasong Forestry Complex owned by Yayasan Sabah.

Scope of Assessment

- The scope of the evaluation is to verify compliance of Rakyat Berjaya Sdn. Bhd. (Empayar Kejora Sdn. Bhd.) with the Sustainable Forest Management License Agreement (SFMLA 09/97) for FMU 23 (partly).
- The assessment is in accordance with the terms of the agreement for the "Sabah Legality Standard Principles 1 4 dated 1 January 2024 (SFD-TLAS-006).
- Site evaluation to verify and report the level of compliance by Rakyat Berjaya Sdn. Bhd. and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not comply adequately with a criterion.
