Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Major Gap **002/2023** shall be addressed within 2 months by July 2023. No action was taken by Aturmaju (Sabah) Holding to register workers and contribute monthly under SOCSO; thus, the Major Gap remains outstanding.

Recommendations

Aturmaju (Sabah) Holding Sdn. Bhd. has not demonstrated compliance with the Sabah Standard Principles 5-6 Chain of Custody as non-compliance was identified under Criterion 5.3 and is NOT recommended to receive a GFS Statement of Compliance or Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

Major Gaps shall be addressed within two months by July 2023.

Gap 002/2023 (Major) Outstanding – Checklist 5.3.1, 5.3.5: Aturmaju (Sabah) Holding shall register all workers and contribute under SOCSO as required.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

Gap 001/2023 (minor) – Checklist 5.1.2: Aturmaju (Sabah) Holding shall record all log transfers to the sawmill in Appendix 3 and correctly calculate the carry forward stock.

Gap 003/2023 (minor) – Checklist 5.3.2, 5.3.7, 5.3.8: Aturmaju (Sabah) Holding shall conduct safety and fire training for workers annually.

The next surveillance visit is scheduled for May 2024.
