Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Gap 001/2022 (Minor) Outstanding – Checklist 5.2.4: Innora shall update the current CoC procedures with respect to the current personnel and operations.

Gap 002/2022 (Minor) Outstanding – Checklist 5.3.8: Innora shall conduct fire training and maintain training records.

Gap 004/2022 (Minor) Outstanding – Checklist 5.3.4: Innora shall report accidents and submit JKKP 6 to DOSH.

Gap 001/2023 (Raised to Minor) – Checklist 5.2.2: SFD shall stamp the removal pass for suppliers that have been awarded Sabah TLAS-CC. SFD shall update the SFD Certrax database.

Gap 002/2023 (Raised to Minor) – Checklist 5.3.1 & 5.3.5: Innora & the contractor shall register workers under SOCSO and foreign workers shall have a valid work permit.

The next surveillance visit is scheduled for March 2024.
