## **Overview of Licensee:**

- Benta Wawasan Sdn. Bhd. (Benta Wawasan) is the licensee of the concession, based on the Tree Plantation and Forestry Management Agreement JP(TKA)122/96(CO). Benta Wawasan assigned Rakyat Berjaya Sdn. Bhd. (Rakyat Berjaya) to manage an area of 26,764 ha located in the Kalabakan and Gunung Rara Forest Reserve (FMU 26).
- Rakyat Berjaya appointed Golden Borneo Palm Sdn. Bhd. (Golden Borneo Palm) to develop and manage the licensed area as an oil palm plantation.
- Rakyat Berjaya also appointed Timjadi Sdn. Bhd. (Timjadi) to carry out timber sale and log extraction to clear the land for oil palm plantation.
- Golden Borneo Palm engaged Bakat Saga Sdn. Bhd. and Usahawan Borneo Greenwood Sdn. Bhd. to provide manpower to Golden Borneo Palm.

## **Environmental Context:**

- Elevation 40 m to 1,219 m above sea level. The dominant soil associations found within the project site is Maliau, which covers approx. 70% of the area. Site topography:
  - $\circ \geq 20^{\circ} = 67\%$  or approx. 18,000 ha
  - $\circ$  21<sup>0</sup> 25<sup>0</sup> = 8% or approx. 2,219 ha
  - $\circ \geq 25^{\circ}$  (including road/river buffers) = 25% or approx. 6,674 ha
- The major river within the licensed area is Sg. Kalabakan, which drains into the Cowie Bay.
- 4 tributaries within the licensed area flow into Sg. Kalabakan. The 4 tributaries are Sg. Anjeranjermut, Sg. Kanakanak, Sg. Tiagau and Sg. Sumagas.
- Original vegetation was Lowland Dipterocarp Forest up to 300 m asl and Hill Dipterocarp Forest between 300 m and 750 m asl.
- The most common wildlife sighted prior to conversion was, orang-utan (*Pongo pygmaeus*), Borneon pygmy elephant (*Elephas maximus borneensis*), Long-tailed macaque (*Macaca fascicularies*), Borneon gibbon (*Hylobates mulleri*), Giant squirrel (*Ratufa affinis*), Plantain squirrel (*Callosciurus notatus*), Slender squirrel (*Sundascu temuis*), Wild boar (*Sus barbatus*), Sambar deer (*Cervus unicolor*), Red muntjak (*Muntiacus muntjak*), Mouse deer (*Traganus sp.*), Sun Bear (*Helarctos malayanus*), Civet (*Viverra tangalunga*), Clouded leopard (*Neofelis nebulosa*), Marble cat (*Felis marmorata*), Short nose fruit bat (*Cynopterus brachotis*) and Long tongued nectar bat (*Macroglossus minimus*).

## FDS-TLAS-006

Sabah Forest Management Area, Kalabakan and Gunung Rara Forest Reserves, Tawau District Sabah" was conducted by an appointed environmental consultant firm, Envsolve Sdn. Bhd. and submitted to the Environmental Protection Department in 2011. Supplementary revisions for the protection of over 6,100 ha were added to the EIA report by Kiwiheng Environmental Consultants Sdn. Bhd. and submitted to the Environmental Protection Department in March and April 2016.

• Subsequently, a re-assessment of EIA was conducted and approved by the Environmental Protection Department on 25/05/2016 (Ref.#: JPAS/PP/21/600-1/01/1/286 Klt.2) which covered the entire Golden Borneo Palm's area.

## **Social Context:**

• No communities live within the licensed area, and local communities have no claims on lands within the licensed area.

### Scope of Assessment

- The scope of the evaluation is to verify compliance of **Benta Wawasan Sdn. Bhd. (Golden Borneo Palm Sdn. Bhd.)** with the JP(TKA)122/96 (CO) for FMU 26 (partly).
- The assessment is in accordance on the terms of the agreement for the "Sabah Legality Standard Principles 1 4 dated November 2020 (SFD-TLAS-002).
- Site evaluation to verify and report the level of compliance by **Benta Wawasan Sdn. Bhd.** and **Golden Borneo Palm Sdn. Bhd.** to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not demonstrate adequate compliance to a criterion.

### Highlights of Assessment

(Major Gaps = 0; Minor Gaps = 2; Observations = 0)

**Benta Wawasan Sdn. Bhd. (Golden Borneo Palm Sdn. Bhd.)** has complied with the Sabah Legality Standard (SFD-TLAS-002) as no non-compliance was identified during the assessment on 15 – 19 January 2024.

Summary of status of operations by Principle:

### Principle 1.

Benta Wawasan signed a Tree Plantation and Forestry Management Agreement JP(TKA)122/96(CO) to develop plantations. Benta Wawasan assigned Rakyat Berjaya, which subcontracted Golden Borneo Palm to develop and manage an area of 26,764 ha located in Kalabakan and Gunung Rara Forest Reserve.

The SFD issued a separate coupe for Oil palm plantation and land preparation (salvage logging). Firstly, a salvage logging coupe permit will be issued on the area, allowing salvage logging to be conducted and subsequently, another coupe permit will be issued for the oil palm plantation after the completion of salvage logging. A closing coupe inspection is carried out after the salvage logging activity is completed.

### January 2024: Gap 001/2024 (minor) - Checklist 1.2.1

A copy of the approved EIA (2016) was not available to support operational compliance with EIA requirements.

The Environment Protection Department (EPD) has noted that the distance from the riparian reserve to the water pump in BW.9/99 is 45 meters and instructed Golden Borneo Palm to implement control measures and always protect the riparian reserve. Which is based on a 30 m buffer zone to protect the stream.

### Principle 2.

Demarcation of areas prohibited from harvesting, such as steep slopes, riparian reserves and buffer zones, were identifiable on the ground. No evidence of a disturbance was observed during the field assessment.

Incorrect stamping of "Sabah TLAS CC" on the removal pass for Golden Borneo Palm.

### Principle 3.

Records of fees and royalty payments were maintained.

**Gap 002/2024 (minor) – Checklist 2.2.7:** SFD shall not stamp "Sabah TLAS CC" on the removal pass for Golden Borneo Palm since they're non-compliant under the Sabah TLAS assessment.

The next annual surveillance audit will be scheduled for January 2025.
