Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

JV Teguh Sdn. Bhd. (JV Teguh) is, on and from 31/03/2010, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Malaysia, with registration #: 201001011846 (896509-M). JV Teguh purchases sawn timber and plywood and re-bundling them. JV Teguh sells sawn timber and plywood to the local market and exports sawn timber exclusively to Mauritius.

The tenancy agreement was made on 01/01/2019 between JV Teguh (The Landlord) agreed to let the premise to Power Timber (The Tenant) from 01/01/2020 to 31/12/2029.

#### **Associated Organizations & Subcontractors:**

JV Teguh does not engage other companies as their subcontractor to produce, manufacture products or provide manpower.
