Borneo Benar has a tenancy agreement with Borneo Build & Supply and was given consent by Makeson to rent land & building to Borneo Build & Supply.

Associated Organizations & Subcontractors:

Borneo Benar does not engage subcontractor to produce, manufacture products or provide manpower. Borneo Benar and Borneo Build & Supply share the same processing facilities.

Gap 002/2024 (minor) – Checklist 5.3.2: Borneo Benar shall ensure that the total foreign workers employed is within the approved quota.

Gap 003/2024 (minor) – Checklist 6.1.5: Borneo Benar shall ensure that the sales invoice and packing list from Borneo Build & Supply stated the Sabah TLAS Compliance Certificate number since Borneo Build & Supply selling Sabah TLAS products.

Observation 001-2024 – Checklist 5.1.2: Borneo Benar shall follow up with the SFD and SFD shall expedite the renewal of timber supplier license.
