Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Rich Bay Corporation Sdn. Bhd. (Rich Bay Corporation) is, on and from 19/05/1990, incorporated under Companies Act 2016, and is registered in Kota Kinabalu, Sabah, Malaysia, with registration #: 199001006458 (198028-M). Rich Bay Corporation purchases sawn timber & plywood for the surrounding area and has had no exports activities since November 2023.

The sub-lease agreement was made on 01/12/2020 between Jomilus Bin Owon (Sub-Lessor) and Rich Bay Corporation (Sub-Lessee), letting the Demised premises to Rich Bay Corporation for a period of 10 years starting 01/12/2020 to 30/11/2030.

Associated Organizations & Subcontractors:

Rich Bay Corporation engages Inspiration Furniture as their sub-contractor to provide manpower. However, SOCSO and EPF are the responsible of the sub-contractor.

Gap 004/2025 (minor) – Checklist 5.3.6: Rich Bay Corporation shall conduct work safety training for workers annually.

Gap 005/2025 (minor) – Checklist 6.4.1: Rich Bay Corporation shall establish summary of raw material purchase, Finished Goods and sales record.

The next surveillance visit is scheduled for May 2026.
