#### **Terms of Assessment**

Compliance is defined when the organization demonstrates that there is no noncompliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

The previous assessment was conducted in March 2022 that resulted in 2 gap(s) and 0 observation(s) (Report #: GFSSBH 004-320).
