Organization Information:

Shin Yang Sdn. Bhd. (97865-T) (Shin Yang) was incorporated on 24th February 1983, with the incorporation of Shin Yang, many sister companies and subsidiaries developed over time. Today, Shin Yang group of companies has become a powerful leading corporation with diversified business activities such as construction, shipping (domestic & international), real estate, forest timber licenses, agricultural and forestry plantations, guarrying and other small businesses.

Description & Licenses:

Based on the approved Forest Management Plan (FMP), FTL No. T/3432 (Nibong FMU) licensee holder is Sarawak Timber Industry Development Corporate (STIDC). Shin Yang Sdn. Bhd. manages the FMU area. STIDC and Shin Yang signed the contract for the Extraction of Timber on 22/09/2004 and a Supplementary Agreement between STIDC and Shin Yang dated 03/03/2006. FTL No. T/3432 (Nibong FMU) is located at upstream of Sg. Bahau and Sg. Melarang, in Kapit Division and located about 180km southeast of Bintulu town and about 130km east of Kapit town. The terrain of the area is classified in accordance with Forest Type Map B produced by the FDS. As a result, 90% of the area is estimated to comprise fairly steep terrain with slopes predominantly in the 5-35° range (terrain Classes II and III).

Management / Land Tenure:

The FTL No. T/3432 (Nibong FMU) was granted a forest logging re-entry/harvesting license for Coupe Area FTL No. T/3432 by the State Government through the Forestry Department of Sarawak (FDS), Kuching on 09/07/2004. As of the recent assessment, Shin Yang has paid a renewal fee to FDS on an annual basis for FTL No. T/3432 covering a total gross area of 54,143 ha for a period of 29/07/2021 to 28/07/2022 as per

Management Planning (FMP / GP):

Forest Management Plan (FMP) for FTL No. T/3432 (Nibong FMU) was approved by the FDS on 19/02/2021 [FDS Ref. #: (04) JHS/600-3/7/102/Jld.12]. Based on an approved FMP, the company has redefined coupe areas to 25 coupes and renumbered the coupe areas. Annual Cutting Area (ACA) is 1,854.8 ha/year with 25 years in one cutting cycle. The Annual Allowable Cut (AAC) for FTL No. T/3432 is estimated at 30,047.76 m³/annum (*FMP page 24*). The diameter cutting limit is ≥DBH 50cm for Dipterocarp species and \geq 45cm for non-Dipterocarp species (*FMP page 23*).

The General Harvesting Plan (GP) for FTL No. T/3432 (Nibong FMU) was approved by the FDS on 22/12/2020 [FDS Ref. #: (30)JHS/600-3/7/110/Jld.4]. The approved GP for FTL No. T/3432 (Nibong FMU) covers an area of 54,143.0 ha. An operable area is 46,370.0 ha while the other area 7,773.0 ha are Terrain IV, Shifting Agriculture (SA), Buffer Zone (BZ), Water Catchment (WC), HCV and the inoperable areas.

The FDS approved the detailed Harvesting Plan (DP) for Coupe 01AR on 24/05/2021 [Ref. #: WPO.600-3/2/1(90)Jld.5]. The approved DP for Coupe 01AR covers an area of 2,333.0 ha with an operable area of 1,929.0 ha.

Operational activities:

No harvesting activities have started yet. Pre-Felling Checking for Block 1 and Block 12 was approved by the FDS following an inspection on 17/12/2021 (Ref.#: (18)PHWBTU/628.365.1-T3342/JLD.1 dated 04/01/2022). The company has not submitted an application for Operation Heading 5. Shin Yang Trading had planned to operate in Coupe 01AR

Environmental context:

Based on the current EIA: (Approval Ref. #: (15) NREB/6-3/2F/34 dated 24/09/2009)

Forest type and history of management

FTL No. T/3432 is located at the upstream reaches of Batang Balui up to Sg. Bahau and Sg. Malarang, in Kapit Division. The timber license is registered as FTL No. T/3432 and located about 180km southeast of Bintulu town and about 130km east of Kapit town.

The southern and western boundaries of the project site border the river Batang Balui and its tributary Sg. Malarang. The entire area rests on undulating to very steep, hilly land. It is accessible via the existing Bakun-Murum Road, which continues into the network of existing logging tracks for about 150-200 km.

Principal commercial species

The ground vegetation was dominated by numerous seedlings and saplings, particularly those of the Dipterocarpaceae. Palms like Licuala and Pinanga were also common but with a localized distribution. Other Shed-Tolerant plants included herbs in the families of Begoniaceae, Araceae. Gesneriaceae and Zingiberaceae. Rattan of the genera Calamus, Daemonorops and Korthalsia were encountered. Many other plant groups made up the diversity of the forest, like climbers' epiphytes and ferns. Shifting cultivations areas were occupied by secondary vegetation of different ages and species compositions. Species of Macaranga, Adinandra, and Ficus were seen in the older forest.

Specific biological values (e.g. rare or endangered species)

A comprehensive survey conducted in the Sg. Balui and Sg. Murum catchment, in conjunction with Bakun Dam EIA, recorded 27 species of frog, 42 species of mammals, and 187 species of birds (CTTC 1995). According to Caldercott (1986), 19 species are commonly hunted, and 37 species are kept as trophies and pets. As part of a study on the impact of hunting on wildlife densities, Bennett et al. (1995) reported the presence of Borneon gibbon, red langur, pig-tailed macaque, barking deer, and mousedeer at Nanga Gaat in the upper reaches of Batang Baleh River, which is a tributary of Batang Rajang.

Environmental services (e.g. critical watersheds, wildlife corridor, etc.) provided by the forest

The majority of the licensed area is covered by remnants of logged-over hill forest. Shifting cultivation areas was observed during the EIA field visits within coupes No. 6 and 8. The licensed area is located in the upstream catchment of Batang Balui from its tributaries Sg. Bahau and Sg. Malarang, within kapit's gazetted water catchment area of approximately 3,466 Ha. The concession is located upstream of the Bakun Dam Catchment by about 60 km. The proposed Murum Dam, re-entry project is situated along another river system (under Batang Balui catchment) of the proposed dam that will not result in significant impacts by forest operations.

Due to rugged terrain and long distance from any major towns, no agricultural projects were located in its immediate vicinity. The licensed area is surrounded by forest plantation developments that include the Garu Skyline about 50 km southwest, Bahay-Linau about 50 km southeast, Immense Fleet about 100 km west, Samling about 140 km northwest and Melekun Raplex about 100 km northwest.

The Kapit Catchment area have several water in-take points that include Ng Entawau, Kapit, Belaga and Sg. Koyan intake points that are located more than 45 km away from the project area which is beyond the 8-km radius stipulated in the water ordinance 1994.

Environmental Impact Assessment (EIA) •

Changes were made for the total area at FTL No. T/3432 and the NREB have advised Nibong FMU to conduct an Environmental Management Planning (EMP) instead of EIA. Hence, Shin Yang has engaged a new EIA consultant, ESI Sampling Sdn. Bhd. to develop an EMP for FTL No. T/3432. The EMP was submitted to NREB and pending approval.

Social context

Social Assessment:

Shin Yang has conducted an internal SIA (Ref. #: Nibong/T3432/SIA) in June 2020 for FTL No. T/3432 and incorporated in the approved FMP to identify communities within and adjacent to the licensed area. Three (3) communities Long Jawe, Long Bulan, and Batu Keling were identified with land and use right claims within the concession.

Key findings of social assessment:

Shin Yang has conducted an internal SIA in June 2020 (Ref. #: Nibong/T3432/SIA) for FTL No. T/3432. The result identified three (3) local communities that are highly dependent on FTL No. T/3432.

Highlights of Assessment

STIDC (Shin Yang Sdn. Bhd.) has complied with the Sarawak Legality Standard (Principles 1-4) as *no* non-compliance was identified during the field verification assessment in January 2022.

Summary status of operations against each principle.

Principle 1:

Forest Management Plan (FMP) and the General Harvesting Plan (GP) for FTL No. T/3432 have been approved based on a 25-year cutting cycle. Shin Yang Trading has redefined coupe areas to 25 coupes and renumbered the coupe areas in FTL No. T/3432. STIDC (Shin Yang) is compliant with license requirements, EIA requirements and management planning guidelines. The company is currently only conducting preparation activities (PEC 1-4) for future harvesting operations in Coupe 01AR.

Principle 2:

Shin Yang has demonstrated compliance with forestry operation standards, demarcation of boundaries and identification of areas for protection, tree enumeration, and worker safety and health. As of the assessment, there is no logging operation commenced yet. The company has approval for Pre-Felling Checking by FDS since December 2021 for Block 01, and Block 12, inside Coupe 01AR.

FDS requires use of Reduced Impact Logging techniques with a diameter cutting limit for Dipterocarp, 50+ cm DBH and non-Dipterocarp is 45+ cm DBH (Ref. #: WPO.628.365.1(III)-01 dated 06/10/2020).

Workers are legally employed and the company contributes to SOCSO as required.

September 2020: Observation 001-2020 – Checklist 2.1.4

The manned gate (Security Gate Sg. Bahau; GPS: N 02° 15' 54.1"; E 114° 20' 40.1") was observed to lack adequate communication system, fire extinguisher, first aid kit.

January 2022: Observation 001-2020 (Addressed)

The company provided a standby motorcycle to report any emergency cases, a fire extinguisher and first aid kit that in good condition.

September 2020: Observation 002-2020 – Checklist 2.5.8

Identification of road hazards needs improvement (e.g. road banks directly connected to steep slopes, broken bridge barriers, sharp corners, deep potholes, landslide).

January 2022: Observation 002-2020 (Addressed)

Warning signs & hazard tapes were erected for identified high-risk hazard areas.

Principle 3:

Shin Yang demonstrated compliance with payment of fees for operations in FTL No. T/3432 as required. As of the assessment, no logging operations were being conducted. The company is utilizing previously
