#### Terms of Assessment

Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

### **Associated Organizations & Subcontractors:**

Jakinta Trading engaged RM Services in Kota Kinabalu to handle the export documentation.

# **Description of the Supply Chain:**

From October 2022 to October 2023, Jakinta Trading purchases round logs from Kinsafajar Sdn. Bhd. and Tropical Origin Sdn. Bhd., which originated from the suppliers as below:

Gap 001/2023 (minor) - Checklist 5.2.2: SFD shall be consistent in stamping "Sabah TLAS CC" on the removal pass for logs sources from Sabah TLAS compliant and "used" as required.

**Observation 001-2023 – Checklist 6.1.2:** Jakinta Trading shall maintain copies of removal passes for all export consignments.

The next surveillance visit is scheduled for November 2024.
