Terms of Assessment

The scope of the evaluation is to verify compliance of Yang Chuan Trading Sdn. Bhd. to the criteria within the Sabah Timber Legality Assurance System (TLAS) Principle 5 - Mill Operations and Principle 6 - Trade and Customs standards. Compliance is defined when the organization demonstrates that there is no noncompliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Limitations of Assessment

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. Auditor's reporting of information presented by the client are taken as accurate, unless evaluated differently through the observations made during the assessment. All information presented in the report is accurate and complete to the best of knowledge of GFS.

Background Information:

Yang Chuan Trading Sdn. Bhd. (Yang Chuan Trading) is registered in Sabah, Malaysia, with registration #: 199201000911 (232415-V). Yang Chuan Trading imports plywood from Indonesia, Vietnam, China & Peninsular Malaysia and sells it for the Sabah market. Yang Chuan Trading operates a warehouse facility and handles imported material.

Currently, Yang Chuan Trading is in the process of transferring its operations to YC Supplies Sdn. Bhd. (YC Supplies) since 2023. As part of this transition, YC Supplies has registered for Exporter, Importer, and Timber Supplier licenses with the SFD and has been operating under these licenses since August 2023.

The previous assessment was conducted in February 2023 that resulted in 8 gap(s) and 0 observation(s) (Report #: GFSSBH 004-468).

Yang Chuan Trading does not engage subcontractors to provide or manufacture products.

Gap 001/2023 (minor) Outstanding – Checklist 5.2.1, 5.2.2, 5.2.3: Yang Chuan Trading shall ensure the materials received are accompanied by a removal pass and the arrival book is complete by including the supplier's name, volume, species, removal pass and Sabah TLAS status as required. SFD shall ensure all removal passes are stamped as "Used".

Gap 003/2023 (minor) Outstanding – Checklist 6.2.3, 6.2.8, 6.3.1: Yang Chuan Trading shall maintain all import inspection receipt in its office.

Gap 004/2023 (minor) Outstanding – Checklist 6.2.6: Yang Chuan Trading shall maintain all SFD import license approval in its office.

Gap 005/2023 (minor) Outstanding – Checklist 6.4.1, 6.4.2: Yang Chuan Trading shall maintain all import documents for materials received from Sarawak in its office.

Gap 001/2024 (minor) – Checklist 5.2.7: Yang Chuan Trading shall ensure receiving records and documents associated to receiving of materials are complete and kept in its office.

Gap 002/2024 (minor) – Checklist 6.4.3: Yang Chuan Trading shall ensure records of buyers, sales, and distribution of timber from Sarawak are complete and available in its office.

The next surveillance visit is scheduled for February 2025.
