# **OBJECTIVES:**

- The objective of this checklist is to verify compliance to the Criteria listed in the Sabah Legality Standard as defined by Principles 1 4 for Sabah dated November 2020 (SFD-TLAS-002).
- Compliance is defined when all applicable criteria are observed to be compliant. A minor Gap to any
  indicator does not constitute non-compliance to a criterion. A Major Gap to any applicable indicator
  does reflect non-compliance to a criterion. Compliance with a criterion where multiple minor gaps are
  identified in indicators under the criterion may reflect non-compliance to the criterion.
- All issues identified under this standard shall be considered appropriate to the scale and degree of forestry operations undertaken by the parties under the agreement.

# **Summary Information**

#### Overview of Licensee:

The State Government of Sabah, through the Land and Survey Department, awarded the land title, Country Lease (CL) No. 155310580, to the Sabah Land Development Board on 23/07/2019 for the purpose of oil palm plantation development. The tenure is from 01/01/2015 to 31/12/2113, subject to the provisions and conditions outlined in the Land Ordinance, Cap. 68.

Based on the land title, the estimated CL total area is 5,316 hectares located at Kg. Lumiri, Nabawan. Subsequently, Sabah Land Development Board has granted the power of attorney to Teraju Hijau Plantations Sdn. Bhd. (Teraju Hijau Plantations) as their logging contractor to conduct the logging activities and payment of any statutory charges. Teraju Hijau Plantations engaged KBC Project to provide manpower within the licensed area.

In 2023, the SFD has granted the Form 1 license to Sabah Land Development Board that will lapse on 01/02/2025 (Ref.#: JPHTN/FRM 700-2/3/123/JLD.4/50 dated 02/02/2023). However, the operation only started in January 2024.

The licensed area is under the jurisdiction of the Keningau District Forestry Office.

# **Current Operations:**

As of the assessment, Teraju Hijau Plantations is still conducting logging operations. Based on records, 26 blocks have been completed for logging, and 7 blocks are undergoing logging operations.

#### **Environmental Context:**

The area is logged over mixed highland dipterocarp forest consisting of Dipterocarps such as *Urat mata, Seraya kuning, Seraya merah, Keruing and Oba suluk* and, other lesser-known species such as *Laran, Pelawan-Pelawan, Mempening, Medang, Keranji, Magas, Rengas*, etc.

The altitude varies between 493m to 1,257m a.s.l.

The nearest forest reserves are Pensiangan Forest Reserve (Class I) in the north, Sg. Tagul Forest Reserve (Class II) in the south, and Sg. Telekosang Forest Reserve (Class II) in the southwest. The main river in the licensed area is Sg. Talangkai and its tributaries, which flow towards Sg. Sapulut.

The project area is mainly underlain by Crocker and Maliau Association. The major soil type is the acidic and nutrient poor Orthic acrisols.

<sup>\*\*</sup>According to the SFD, before the Form 1 license approval, the initial project area was 5,752 ha; however, in 2019, approximately 436 ha of the area has been excised to *Mini Estate Sejahtera* (MESEJ) Kg. Lumiri, Nabawan, for the development of oil palm plantation.

Terrestrial mammals commonly sighted are Sambar Deer, Borneon Yellow Muntjac, Bearded Pig, Malayan Civet, Common Palm Civet, and Long-tailed Macaque. Avian species identified through calls and sightings: Great Argus, Plaintive Cuckoo and Crested Serpent Eagle. The biggest threat to wildlife in the licensed area is poaching.

Significant impacts:

- Soil erosion exacerbated by topography and conventional logging.
- Water quality deterioration and sedimentation.
- Refugia disturbance.
- Ease of ignition due to increase in fuel loads (logging residue).

The EIA study titled "Proposed 5,752 Hectares of Logging & Oil Palm Plantation at PT.20-10151023, Lumiri, Pensiangan, Sabah" was prepared and approved by the EPD (Ref. #: JPAS/PP/03/600-1/01/1/296(58) dated 03/11/2022).

#### **Social Context:**

Based on the EIA, there are 7 villages associated with the licensed area. The list of villages as follows:

The mitigation measures include community engagement meetings to establish local understanding, the employment of legal foreigners, prioritizing employment and business opportunities for local communities, and the proper implementation of environmental control measures.

- Site evaluation to verify and report the level of compliance by Sabah Land Development Board and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not comply adequately with a criterion.

# **Highlights of Assessment**

(Major Gaps = 5; minor Gaps = 3; Observations = 1)

December 2024: (Major Gaps = 5; minor Gaps = 3; Observations = 1)

Sabah Land Development Board (Teraju Hijau Plantations Sdn. Bhd.) has not complied with the Sabah TLAS requirements (FDS TLAS-006), as non-compliance was identified under Criteria 2.4, 3.1 and 4.1 during the assessment on 30 September-04 October 2024.

#### Summary of status of operations by **Principle**:

#### **Principle 1. Right to Harvest**

Teraju Hijau Plantations demonstrated compliance with the Form 1 license requirements. However, non-compliance was identified based on environmental impact assessment requirements.

#### October 2024: Gap 001/2024 (Major) - Checklist 1.2.5

No evidence that the ECR has been conducted and submitted to the EPD as required.

#### December 2024: Gap 001/2024 (Major) - Outstanding

ECR has not been conducted through Q2 & Q3 of 2024 whereby the company has yet to address the issues raised the ECR consultant.

#### October 2024: Observation 001-2024 - Checklist 1.7.1

Lack of maintenance for boundary demarcation between the licensed area and Sg. Tagul Forest Reserve (Class II).

#### **Principle 2. Forest Operations**

Teraju Hijau Plantations maintained adequate records of logs production and transportation. However, non-compliance was identified in relation to EIA requirements, and regulatory requirements for workers.

#### October 2024: Gap 002/2024 (Major) - Checklist 2.4.1, 2.4.2

No evidence of passport, work permit, employment agreement, COI, foreign workers exceeded the quota of the expired JTK license.

# December 2024:

Records of work permits for foreign workers, employment agreements and COI for all workers remain incomplete. Claims that the undocumented workers are no longer working without evidence are not justified. Inadequate action taken to address Gap 002/2024 (Major).

#### December 2024: Gap 002/2024 (Major) - Outstanding

Inadequate evidence that all workers are legally employed with work permits, employment agreements and COI.

# October 2024: Gap 003/2024 (minor) - Checklist 2.4.3

Lack of fire extinguishers at the Teraju Hijau Plantations workers' guarters.

#### October 2024: Gap 004/2024 (minor) - Checklist 2.4.5

Inadequate work and fire safety training by Teraju Hijau Plantations.

#### October 2024: Gap 005/2024 (Major) - Checklist 2.4.8

No evidence that all workers have been registered and contributed under SOCSO/EPF where required. Lack of DOSH registration.

# December 2024: Gap 005/2024 (Major) - Outstanding

Teraju Hijau Plantations could not provide the SOCSO and EPF to team GFS. Lack of DOSH registration.

# **Highlights of Assessment**

#### **Principle 3. Statutory Charges**

Teraju Hijau Plantations payment of royalties was current. Non-compliance was identified for lack of FD registration of machinery.

# October 2024: Gap 006/2024 (Major) - Checklist 3.1.1

No evidence of FD registration of machinery by Teraju Hijau Plantations.

#### December 2024: Gap 006/2024 (Major) - Outstanding

No evidence of FD registration of machinery and expired FD.

# **Principle 4. Other User Rights**

Based on the EIA, there are 7 villages associated with the licensed area, namely, Kg. Binanun, Kg. Sumbiling, Kg. Nangkawangan, Kg. Lumiri Tengah, Kg. Pohon Batu, Kg. Mamagun, and Kg. Ponontomon. Based on the EIA document, the potential impacts on the community include soil erosion, water pollution, sedimentation, agro-chemical impacts, waste management, and socio-economic effects. The mitigation measures include community engagement meetings to establish local understanding, the employment of legal foreigners, prioritizing employment and business opportunities for local communities, and the proper implementation of environmental control measures.

#### October 2024: Gap 007/2024 (minor) - Checklist 4.1.1, 4.1.3

No evidence that the community areas was mapped and identified by Teraju Hijau Plantations.

## October 2024: Gap 008/2024 (Major) - Checklist 4.1.4, 4.1.5, 4.1.6, 4.1.7

A significant dispute exists and there is no evidence that a formal system for conflict resolution and communication with the community resulting in no community meetings.

**December 2024:** A stakeholder meeting was conducted on 19/11/2024 where discussions were held on the provision of goods and services, alongside initiatives to promote the health and well-being of the villages. However, no system of conflict resolution or community support was developed.

## December 2024: Gap 008/2024 (Major) - Outstanding

Formal system has not been established for conflict resolution and communications with the community to address current disputes and define system to collaborate with the community.

# Recommendations

**Sabah Land Development Board (Teraju Hijau Plantations Sdn. Bhd.)** has not demonstrated compliance with the Sabah TLAS requirements (FDS TLAS-006) as non-compliance was identified under Criteria 1.2, 2.3, 2.4, 3.1, 4.1 and it is NOT eligible to receive a GFS Statement of Compliance or Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

The Major Gap shall be addressed within two months by **December 2024**.

**Gap 001/2024 (Major) Outstanding – Checklist 1.2.5:** Teraju Hijau Plantations shall conduct ECR for Q2-3 of 2024 and address issued raised by the EIA consultant.

**Gap 002/2024 (Major) Outstanding - Checklist 2.4.1, 2.4.2:** SLDB to provide evidence that all workers are legally employed with employment agreements and COI as required.

**Gap 005/2024 (Major) Outstanding - Checklist 2.4.8:** KBC Project shall ensure that all workers contribute to SOCSO/EPF and register under DOSH.

**Gap 006/2024 (Major) Outstanding - Checklist 3.1.1:** Teraju Hijau Plantations shall ensure that all heavy machinery is registered with the SFD.

**Gap 008/2024 (Major) Outstanding - Checklist 4.1.4, 4.1.5:** A formal system shall be established for conflict resolution and communications with the community to address current disputes.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

**Gap 003/2024 (minor) – Checklist 2.4.3:** Teraju Hijau Plantations shall provide an adequate number of fire extinguishers in the dwelling area.

**Gap 004/2024 (minor) - Checklist 2.4.5**: Teraju Hijau Plantations shall conduct the work and fire safety training annually and develop formal training reports.

Gap 007/2024 (minor) - Checklist 4.1.1, 4.1.3: The community used areas shall be mapped and identified for protection as per the EIA requirements.

**Observation 001–2024 Checklist 1.7.1:** Teraju Hijau Plantations shall maintain boundary demarcation between the licensed area and the Sg. Tagul Forest Reserve (Class II).

The next annual surveillance audit will be scheduled for October 2025.
