Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Ho Lian Sawmill Sdn. Bhd. (Ho Lian Sawmill) is registered in Kuala Lumpur, Malaysia, with registration # 050190-T. Sen Rong Wood Sdn. Bhd. (Sen Rong Wood) is registered in Kuala Lumpur, Malaysia, with registration # 1199684-V.

Ho Lian Sawmill (sublessor) has a tenancy agreement with Sen Rong Wood (sublessee) for an initial period of 15 years, commencing from 01/10/2016. Ho Lian Sawmill is responsible for paying licensing regarding the sawmill. Sen Rong Wood produces sawn timber and exports mainly to China.

The previous assessment was conducted in August 2022 that resulted in 0 gap(s) and 2 observation(s) (Report #: GFSSBH 004-382).

## Associated Organizations & Subcontractors:

Sen Rong Wood engages Agensi Pekerjaan MNK Sdn. Bhd. as a subcontractor to handle foreign workers' documentation.
