Summary Information

Overview of Licensee:

On 25/07/2007, Silam Forest Products Sdn. Bhd. (Silam Forest Products) was granted a Licensed Area of approximately 10,326 ha in Bonggaya Forest Reserve by the State of Government under a License #: JP(SBN)03/2007(CO) for 60 years. With this license, the State Government has granted permission to Silam Forest Products to plant, establish and harvest forest products and agroforestry crops under the principles of sustainable environmental management and conservation for economic environmental and social purposes.

A Shareholders' Agreement was signed on 19/11/2007 between Silam Forest Products and Arus Sawit Sdn. Bhd. (Arus Sawit), where the latter agreed to jointly develop the project area into a large-scale Agroforestry Development Project under a Joint Venture Agroforestry Program.

Bonggaya Forest Reserve was first established and gazetted as a Permanent Forest Reserve in 1958. In 1984, Bonggaya Forest Reserve was gazetted and classified as a Commercial Class II FR.

The ADP was approved by the Director of Forestry on 18/04/2008; however, was later revised (approved on 05/12/2008) because of the change in area size after it was surveyed. The actual total area has changed from 10,326 ha to 10,570 ha, an increase of 244 ha.

Note* Area initially planted with oil palm; but high mortality and lack of maintenance the area was left vacant with no re-planting.

Based on Revised ADP (2018-2027), Ref. #: ASSB/2024-165 dated 29/04/2024, acknowledged receipt by the SFD Beluran on 29/04/2024.

Prior to development, an area of 1395.17 ha was planted with oil palm by local villagers. Several surveys were carried out since 2008 as well as operation exercise carried out by the SFD on the planted area that encroaches the concession area. The last exercise carried out together with SFD was in mid-2009 including a completion of firebreak for demarcation of the encroached boundary.

Current Operations:

Natural Forest Management (NFM): No harvesting is planned within the NFM coupe areas. The specified land use activities, as per the NFM coupe permits, include silviculture treatment and enrichment planting.

Oil Palm Plantation: As of the assessment, no new oil palm planting has occurred. The current status of oil palm planting, based on records, is as follows:

Environmental Context:

The Agroforestry project involves oil palm plantation establishment and natural forest management. Approximately 6,167 ha (58.3%) have been developed into oil palm plantations and 2,317.38 ha (21.9%) including steep and riparian areas, are managed under natural forest management. Infrastructure and amenities such as nurseries, base camps, roads, ponds or swamps, dwelling places and office buildings make up about 690.46 ha or 6.5% of the total area.

The licensed area is divided into Zone I – Natural Forest Management and Environmental Conservation Area and Zone II – Oil Palm Plantation, including infrastructure and amenities.

The objectives within Zone I are to manage and sustain the production of high-value timber by rehabilitating all degraded forest areas with indigenous tree species such as Laran (*Anthocephalus cadamba*), Binuang (*Octomeles sumatrana*), Kapur (*Dryobalanops lanceolata*), and *Shorea spp.* throughout the entire contract period.

Topography: The licensed area lies between Sg Makopako at its northern boundary and Sg Tungud near the southern boundary. The eastern half is generally flat to undulating and interspersed with small hills, while the western half comprises higher grounds of low hills. The main soil types are nutrient deficient Orthic acrisols.

Hydrology: The licensed area traversed by Sg. Makopako in the north and Sg. Tungud in the south, along with Sg. Botitian, Sg. Rungus, Sg. Menlong-long, and Sg. Fortuna, which converges into Sg. Tungud. All watercourses in the licensed area eventually flow into the larger Sg. Bonggaya. Preserving steep terrains and riparian zones is essential for the sustainable management and maintenance of the watershed areas in this drainage system.

Flora and Fauna: The natural vegetation of the licensed area, part of the greater Bonggaya Forest Reserve, was dominated by Mixed Dipterocarp Forest in the steeper western portion. Whereas larger areas of continuous swamp forest where drainage is impeded by river levees in the northern boundary and in smaller pockets adjacent to the waterways. Direct sightings of animals in the NFM areas were limited to Borneon Gibbon, Monitor Lizard, Slow Loris, Leopard cat, Common palm civet, Long-tailed and short-tailed macaques. However, recorded footprints indicate the presence of wild pigs and barking deer. Footprints of larger wild cats and sun bears were also seen. The site supports at least one, and probably two Totally Protected Animals (Schedule 1, Part 1, Section 25(1) of the Wildlife Conservation Enactment 1997), namely, the Sun Bear (Helarctos malayanus) and the Clouded Leopard (Neofelis nebulosa).

The EIA study entitled "Environmental Impact Assessment for the Proposed Agroforestry Development at Lot 3, Bonggaya Forest Reserve, Beluran District, Sabah" was conducted by ERM Borneo Sdn. Bhd. and approved by the Environment Protection Department (EPD) on 23/02/2009 (Ref. #: JPAS/PP/17/600-1/11/1/47).

Arus Sawit identified land disputes within the licensed area designated for agricultural production, totalling 1,395.17 hectares. The Sabah Forestry Department (SFD) approved the excision of these areas [Ref. #: JPHTN/BN(S) 700-1//2/1(Jld.3)/26, dated 02/07/2018], and they have been excluded from forest operations. The information was deemed confidential by the SFD during the closing meeting regarding the land dispute.

Scope of Assessment

Silam Forest Products Sdn. Bhd. (Arus Sawit Sdn. Bhd.) has complied with the Sabah TLAS requirements (FDS TLAS-006) as no non-compliance was identified during the assessment on 14-17 April 2025.

Summary of status of operations by **Principle**:

Principle 1. Right to Harvest

A Shareholders' Agreement was signed on 19/11/2007 between Silam Forest Products and Arus Sawit Sdn. Bhd. (Arus Sawit), where the latter agreed to jointly develop the project area into a large-scale Agroforestry Development Project under a Joint Venture Agroforestry Program. Arus Sawit holds an approved Agroforestry Development Plan (ADP), approved by the Chief Conservator of Forests, effective from 01/012018 to 31/12/2027. This 10-year plan pertains to the implementation of agroforestry activities within the partially designated areas of the Bonggaya Forest Reserve, under the provisions of the aforementioned license agreement [JP(SBN)03/2007(CO)].

An Environmental Impact Assessment (EIA) titled "Environmental Impact Assessment for the Proposed Agroforestry Development at Lot 3, Bonggaya Forest Reserve, Beluran District, Sabah" was conducted by ERM Borneo Sdn. Bhd. and subsequently approved by the Environment Protection Department (EPD) on 23 February 2009 (Ref. #: JPAS/PP/17/600-1/11/1/47). Following this approval, EPD-appointed consultants have carried out quarterly environmental monitoring in accordance with regulatory requirements.
