Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Timbers Chapter Sdn. Bhd. (Timbers Chapter) is, on and from 12/07/2006, incorporated under Companies Act 2016, and is registered in Sabah, Malaysia, with registration #: 200601020891 (740644-D). Timbers Chapter has no operation.

CS Biomass Sdn. Bhd. (CS Biomass) is, on and from 05/04/2011, incorporated under Companies Act 2016, and is registered in Sabah, Malaysia, with registration #: 201101011097 (939227-P). CS Biomass produces briquette charcoal for local market and exports them to Japan and Greece.

A Tenancy Agreement between Timbers Chapter (The Landlord) and CS Biomass (The Tenant) was made on 04/08/2021 for 5 years. The Landlord agreed to grant a tenancy of a portion of the Demised Premises) for sawdust, briquette and charcoal productions.

CS Biomass does not engage subcontractor to produce, manufacture products or provide manpower.

**Gap 003/2025 (minor) – Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3, 6.1.4**: CS Biomass shall ensure the current purchasing system is according to the COC procedure.

**Observation 001-2025 – Checklist 5.2.4:** SFD shall ensure all removal passes from the mill to the port and to other mill are stamped as "Used."

**Observation 002-2025 – Checklist 5.3.4:** CS Biomass shall provide adequate showers and toilets at the workers quarters.

**Observation 003-2025 – Checklist 6.3.3:** CS Biomass and SFD shall correctly declare type of material in export document.

The next surveillance visit is scheduled for January 2026.
