Summary Information

Overview of Licensee:

- Kalabakan Borneo Resources Sdn. Bhd. (Kalabakan Borneo Resources) was granted a licensed area of 23,610 ha located within Kalabakan Forest Reserve (FMU 25) by the Sabah State Government under the Sustainable Forest Management License Agreement (SFMLA 04/2018).
- Kalabakan Borneo Resources aims to contribute to Sabah's economic development by practicing sustainable harvesting and regeneration from their plantation's activity.
- The area has been intensively logged from 1976 to 2007. Records indicated that 27 logging licenses were being issued within the area.
- Previously, Kalabakan Borneo Resources was granted the management of approximately 53,610
 ha of the Commercial Class II Forest Reserve. However, the agreement was revised and
 changed to the current granted area, which will be happening for 100 years, starting from
 12/04/2018.
- The previous assessment was conducted in April 2022 that resulted in 2 gap(s) and 3 observation(s) (Report #: GFSSBH003-122a).

Current Operations:

No logging has started (NFM-RIL/ITP-salvage) within the licensed area as of 24/03/2023.

Environmental Context: (based on FMP)

- The SFMLA area is classified as a Class II Commercial Forest Reserve reserved for the supply of timber and other produce.
- There are five (5) forest types: the Upland Mixed Dipterocarp & Kerangas Forests, Lowland Mixed Dipterocarp & Kerangas Forest, Lowland Mixed Dipterocarp Forest, Upland Kerangas Forest and Lowland Kerangas Forest.
- Common dipterocarps found are *Dryobalanops lanceolata, Shorea parvifolia, S. leprosula* and *S. laevis.* Pioneer species of commercial value such as *Neolamarckia cadamba* (Laran), *Octomeles sumatrana* (Binuang) and Magas are also present.
- There are 17 species of mammals recorded within the area, including Borneon orang-utan (*Pongo pygmaus*), Borneon elephant (*Elephas* maximus) and Borneon banteng (*Bos javanicus*). Other large mammals include Sambar deer, bearded pig, clouded leopard, Malayan sun bear, greater mouse deer, pig-tailed macaque, Borneon yellow muntjac and red muntjac.
- Seven (7) Borneon endemic bird species were recorded within the FMU 25 (including in the license area). Bucerotidae, Nectariniidae and Pellorneidae were the most species of bird families. There are also Black Hornbills, Bushy-crested Hornbills, Helmeted Hornbills, Rhinoceros Hornbills, Wreathed Hornbills and Wrinkled Hornbills.
- The licensed area consists of three (3) main rivers, namely the Sungai Luis, Sungai Tambalunan and Sungai Serudong. The area is a vital watershed for the Kampung Serudong Laut community.
- Kalabakan Borneo Resources has an approved EIA study from EPD (Ref.#: JPAS/PP/KLBKN/600-1/01/3/75(23), dated 27/07/2022) which was not available to confirm information in the FMP.

Social Context:

- Based on the FMP there are no local communities living within or adjacent to the licensed area.
 Kg. Piorgon and Kg. Serudong Laut are located 8 km and 23 km, respectively, from the border of the licensed area.
- Kg. Piorgon is an old village that has been abandoned where; the communities went back to their former village, Kg. Serudong Laut.
- No Social Baseline Survey has been conducted and EIA was not available to confirm the information in the FMP.

Scope of Assessment

- The scope of the evaluation is to verify compliance of Kalabakan Borneo Resources Sdn. Bhd. with the Sustainable Forest Management License Agreement (SFMLA 04/2018) for FMU 25
- The assessment is in accordance on the terms of the agreement for the "Sabah Legality Standard Principles 1 - 4 dated November 2020 (SFD-TLAS-002).
- Site evaluation to verify and report the level of compliance by Kalabakan Borneo Resources Sdn. Bhd. and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not demonstrate adequate compliance to a criterion.

Kalabakan Borneo Resources Sdn. Bhd. has not complied with the Sabah Legality Standard (SFD-TLAS-002) as non-compliance was identified under Criteria 1.3 & 1.6 during the assessment on 20 - 24 March 2023.

Summary of status of operations by Principle:

Principle 1.

The State Government granted a Sustainable Forest management License Agreement (SFMLA 04/2018) to Kalabakan Borneo Resources for 100 years.

Kalabakan Borneo Resources has an EIA approved by the EPD on 27/07/2022 [Ref.#: JPAS/PP/KLBKN/600-1/01/3/75(23)].

Kalabakan Borneo Resources has a 10-year approved Forest Management Plan / Plantation Development Plan describing the concession and activities expiring in 2031, including salvage logging and conversion of Strata 2 & 3 forest areas totaling 20,633 ha to ITP.

An annual work plan for 2023 was submitted and approved by SFD as required.

March 2022: Gap 001/2022 (Major) - Checklist 1.3.2, 1.6.1

Highlights of Assessment

Contradiction between FMP land use planning and establishment of ITP on Strata 2&3 forest areas that contain exploitable volumes of trees over 60 cm diameter, with SFMLA conditions that limit plantation establishment to areas of degraded forest land having no exploitable volume of trees greater than 60cm dbh and insufficient regeneration, but not exceeding 25 degrees slopes.

May 2022: Gap 001/2022 (Major) - Outstanding

The land use planning in the FMP has not been revised to comply with the SFMLA conditions on the conversion of natural forests to ITP.

March 2023: Gap 001/2022 (Major) - Outstanding

No evidence that Kalabakan Borneo Resources has revised the FMP to comply with the SFMLA conditions on the conversion of natural forests to ITP.

May 2023: Gap 001/2022 (Major) - Outstanding

No evidence that Kalabakan Borneo Resources has revised the FMP to comply with the SFMLA conditions on the conversion of natural forests to ITP.

March 2022: Observation 001-2022 Checklist 1.2.1

An EIA must be developed and approved by EPD that clearly defines mitigation of environmental impacts in relation to SFLMA requirements and planned conversion of natural forests classified as strata 2 & 3 into timber plantations prior to starting logging operations.

March 2023: Gap 001/2023 (Raised to Minor)

The EIA report approved by EPD, was not available for use by Kalabakan Borneo Resources to mitigate impacts of conversion with respect to compliance with SFMLA requirements.

March 2022: Observation 002-2022 Checklist 1.3.2.1

The policy statement does not reflect the planning for the conversion of 87% of the forest areas under strata 2 & 3 to Industrial Timber Plantations (ITP).

March 2023: Gap 002/2023 (Raised to Minor)

No evidence of policy statement revision inside the FMP for current activities.

Principle 2.

Kalabakan Borneo Resources has not started any forest operations as of the assessment. Instead, Kalabakan Borneo Resources focuses on road surveying and infrastructure construction.

March 2022: Observation 003-2022 - Checklist 2.3.7

The Forest Fire Management Plan has not been developed yet.

March 2023: Observation 003-2022 (Addressed)

The Forest Fire Management Plan (FFMP) has been submitted and approved by the Chief Conservator of Forests.

March 2023: Observation 001-2023 - Checklist 2.3.1

The COI application for forest workers was submitted on 15/03/2023 and is pending approval from SFD.

March 2023: Observation 002-2023 - Checklist 2.3.2

No evidence of training of forest workers for RIL and salvage logging as required prior to starting logging operations.

Principle 3.

Kalabakan Borneo Resources has paid applicable fees to SFD as required. Heavy machineries are in the process to be registered to SFD.

As of the assessment, there is no logs production.

March 2022: Gap 002/2022 (Minor) - Checklist 3.1.1

The OP number JP(SER)OP03/2021 was expired on 02/03/2022.

March 2023: Gap 002/2022 (Minor) - Closed

Kalabakan Borneo Resources has renewed the OP for JP(SER)OP03/2021.

The heavy machinery registration was submitted to SFD and is pending approval.

Principle 4.

Not applicable - No local communities are living within or adjacent to the licensed area. Kg. Piorgon and Kg. Serudong Laut, are located 8 km and 23 km, respectively, from the border of the licensed area. Therefore, according to the approved FMP, conducting a Social Baseline Assessment was not required.

The Major Gap 001/2022 shall be addressed within two months by June 2023. No evidence that Kalabakan Borneo Resources has revised the FMP to comply with the SFMLA conditions on the conversion of natural forests to ITP; thus, the Major Gap remains outstanding.

Recommendations

Kalabakan Borneo Resources Sdn. Bhd. has not demonstrated compliance with the Sabah Legality Standard (SFD-TLAS-002) as non-compliance was identified under Criteria 1.3 & 1.6 and is not recommended to receive a GFS Statement of Compliance or Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

The Major Gap shall be addressed within two months by June 2023.

Gap 001/2022 (Major) Outstanding - Checklist 1.3.2, 1.6.1: Kalabakan Borneo Resources shall revise the land use planning in the FMP to comply with SFMLA license requirements regarding conditions for ITP development and ensure compliance with EIA requirements following the completion of EIA assessment and approval by EPD.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

Gap 001/2023 (Raised to Minor) - Checklist 1.2.1: The approved EIA report shall be available to the operations manager and used in mitigating impacts of conversion with respect to compliance with SFMLA

Gap 002/2023 (Raised to Minor) - Checklist 1.3.2.1: The policy statement should not be misleading and shall reflect the objectives of concession management in relation to SFMLA and EIA requirements.

Observation 001-2023 – Checklist 2.3.1: SFD shall expedite the COI approval.

Observation 002-2023 – Checklist 2.3.2: Kalabakan Borneo Resources shall train forest workers for RIL and salvage logging as required prior to starting logging operations.

Observation 003-2023 - Checklist 3.1.1: Kalabakan Borneo Resources shall ensure that heavy machinery is registered as required prior to starting operations.

The next annual surveillance audit will be scheduled for March 2024.
