Borneo Build & Supply only sells sawn timber (back-to-back sales) with Borneo Benar Sdn. Bhd. (Borneo Benar).

Borneo Build & Supply Sdn. Bhd. has a tenancy agreement with Borneo Benar and was given consent by Makeson to rent land & building through Borneo Benar.

Associated Organizations & Subcontractors:

Borneo Build & Supply does not engage subcontractor to produce, manufacture products or provide manpower.

Borneo Benar and Borneo Build & Supply share the same processing facilities.

Description of the Supply Chain:

From March 2023 to March 2024, Borneo Build & Supply has not purchase sawn timber and has no operation since April 2019. The company keeps old stocks in the mill.
