# **OBJECTIVES:**

- The objective of this checklist is to verify compliance to the Criteria listed in the Sabah Legality Standard as defined by Principles 1 4 for Sabah dated 01<sup>st</sup> January 2015 (SFD-TLAS-002).
- Compliance is defined when all applicable criteria are observed to be compliant. A Minor Gap to any indicator does not constitute non-compliance to a criterion. A Major Gap to any applicable indicator does reflect non-compliance to a criterion. Compliance for a criterion where multiple minor gaps are identified in indicators under the criterion may reflect non-compliance to the criterion.
- All issues identified under this standard shall be considered appropriate to the scale and degree of forestry operations undertaken by the parties under the agreement.

# **Summary Information**

### **Overview of Licensee:**

- The Sabah State Government has awarded both the Bengkoka Forest Reserve and Tambalugu Forest Reserve (FMU 2), with a combined hectarage of 6,467 ha to Gerak Saga Sdn. Bhd. (Gerak Saga) for industrial tree plantation development. Both forest reserves are managed as a single entity supplemented by 4 Coupes.
- The licensed area is being planted with *Eucalyptus pelita*, Eucalyptus hybrid and *Acacia crassicarpa* based on a harvest cycle of 10 years. Based on the FMP, the net plantable area is approximately 5,625 ha.
- A Sustainable Forest License Agreement (SFMLA), SFMLA 01/2015, was signed on 26<sup>th</sup> October 2016 for 100 years which expires on 31<sup>st</sup> December 2115.
- As prescribed in the SFMLA 01/2015, Gerak Saga has an approved 1<sup>st</sup> 10-year FMP from 1<sup>st</sup> January 2017 – 31<sup>st</sup> December 2026 for Bengkoka Forest Reserve & Tambalugu Forest Reserve - FMU 2.
- Gerak Saga has an FSC license #: FSC-C167381, with code #: CU-FM/COC-873356, valid until 30/05/2026. The company also has a PEFC license #: CU MTCS/FMC 873356, valid until 31/05/2024.
- Gerak Saga has 8 contractors, of which 4 contractors were registered as harvesting contractors with SFD to carry out harvesting, spreading, and site preparation for planting within the licensed area.

- Gerak Saga is currently conducting salvage logging to establish Industrial Tree Plantations.
- As of October 2023, the planted area recorded is 3,049.34 ha with a total planted trees of 5,007,748 for Coupe 1,2,3 and 4.
- As of October 2023, the salvaged logged area recorded is 3545.40 ha with a total production of 324,379.71 m<sup>3</sup>.
- The current operations are according to FMP/PDP/AWP schedules.

# **Environmental Context:**

- Forest Type and History of Management
  - The licensed area consists of the Bengkoka & Tambalugu Class II (Commercial) Forest Reserves with an approximate hectarage of 6,270 ha and 197 ha respectively and lies within Pitas District in Sabah.
  - The licensed area was originally covered in tropical rainforest constituting mainly of the Dipterocarpaceae family. Past management of slash and burn agriculture, coupled with the establishment of tree plantations, has resulted in a patchwork or mosaic of vegetation cover where remnants of the original forest can only be seen on the coastal areas fringed with mangrove forests.
  - The FMU is predominantly covered by *Acacia mangium* forests of mixed ages and densities. Many wildfires also affect the licensed area, leaving areas barren of trees and covered in Lalang and Brackens. There are also small patches of natural forest found in the riverine areas.
- Principal Commercial Species
  - Acacia mangium, considered to be invasive and has dominated the licensed area landscape. As of late, A mangium is susceptible to fungal (*Ceratocystis*) attacks and fire outbreaks during pronounced drought.
  - In line with the requirements of the SFMLA, Gerak Saga will convert the project site to productive stands of *Eucalyptus* spp. and *Acacia crassicarpa* while maintaining, riparian reserves and conservation areas through enrichment planting with native tree species.
- Specific Biological Values (e.g. rare or endangered species)
  - Although the concession area is in a degraded state, with little floral diversity, there are still several wildlife species found in the area, which include the Malayan sun bear, sambar deer, pigtailed macaque, bearded pigs, Tabon scrub fowl and a few birds, amphibian, and reptile species. The Malayan sun bear is Totally Protected under Schedule 1 of the Sabah Wildlife Enactment (WCE) 1997; meanwhile, the pig-tailed macaque, bearded pig and sambar deer are protected under Schedule 2 of the enactment, Environmental Services (e.g., critical watersheds, wildlife corridor, etc.) provided by the forest.

# Social Context:

- Social Assessment Summary
  - Based on the FMP, there are no settlements within the project area in both Bengkoka Forest Reserve and Tambalugu Forest Reserve (EIA, page C3-48 to page C3-49).
  - 12 Villages identified in the peripheral of the licensed area as stated in the FMP midterm review and 13 villages\* are stated in the EIA report.

- Native Customary Rights
  - No areas subject to native customary rights were identified within the licensed area.
  - However, the company has identified approximately 0.1 ha of burial site inside Coupe 4 claimed by Kg. Suang Duyung. The location was mapped and excluded it from the operation.
  - Gerak Saga recognizes the concerns and rights of the communities living adjacent to the Project Area and is dedicated to minimizing and offsetting any social and environmental impacts of the project on their livelihoods.
- Identified communities associated to the FMU
  - Based on the current FMP (page. 26), no local community settlements are situated within the licensed area. There are twelve formal settlements, namely Kg. Kapok, Kg. Kodong, Kg. Kandang, Kg. Jambu, Kg. Gumpa, Kg. Radap, Kg. Kipahung, Kg. Bongkol, Kg. Suang Duyung, Kg. Serupil, Kg. Ungkup and Kg. Kakarangan, found adjacent to the license area. Through a detailed socio-economic study, Gerak Saga has accommodated the local communities that can benefit from this project and has taken the initiative of establishing a Community Development Master Plan to address the social development and to improve the quality of the local communities.
- Community Forestry Projects
  - Implementation of the Community Development Master Plan has become an avenue for employment and a platform to settle grievances and conflict resolution (land claims) among the local communities.
  - There was no NCR claim in the licensed area, however, there were several land disputes identified. The villagers have planted several areas with crops (palm oil, fruits trees and rubber trees). Based on the Coupe Development Plan, approximately 20 ha of the disputed area was

identified and is now temporarily excluded from forest operations (refer to the Coupe Development Plan).

- Gerak Saga is continuously giving assistance and resolving issues that affects the communities through engagements and consultations.

# Scope of Assessment

- The scope of the evaluation is to verify compliance of **Gerak Saga Sdn. Bhd**. with the Sustainable Forest Management License Agreement (SFMLA 01/2015) for FMU 2.
- The assessment is in accordance on the terms of the agreement for the "Sabah Legality Standard Principles 1 - 4 dated 01<sup>st</sup> January 2015 (SFD-TLAS-002).
- Site evaluation to verify and report the level of compliance by **Gerak Saga Sdn. Bhd.** and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not demonstrate adequate compliance to a criterion.

# Highlights of Assessment

### (Major Gaps = 0; Minor Gaps = 0; Observations = 1)

Gerak Saga Sdn. Bhd. has complied with the Sabah Legality Standard (SFD-TLAS-002) as no non-compliance was identified during the assessment on 02-06 October 2023.

#### Summary of status of operations by **Principle**:

#### Principle 1.

Gerak Saga demonstrated compliance with the license requirements, management planning, and submission of documents and ECR reports to the relevant authorities. A Sustainable Forest License Agreement (SFMLA), SFMLA 01/2015, was signed on 26<sup>th</sup> October 2016 for 100 years which expires on 31<sup>st</sup> December 2115.

#### Principle 2.

Gerak Saga demonstrated compliance with the forest operation requirements. Logging contractors were registered with SFD with valid registrations. All property hammer marks are valid.

Gerak Saga has an agreement with the landowner to rent the Bambangan log pond from 01/11/2017 to 31/10/2038. Three Occupational Permits were cancelled since December 2022 and followed up on 11/07/2023. However, the SFD has yet to provide feedback.

Lack of processing cancellation of Occupation Permits by SFD.

#### Principle 3.

Gerak Saga has paid the licensing fees and other charges to Pitas District Forestry Office. The records were available and maintained. Records of royalty payment were available and maintained.

# October 2023: Observation 001-2023 – Checklist 3.1.1

Lack of processing from the SFD for the OP cancellation.

#### Principle 4.

Gerak Saga had identified several villagers surrounding the licensed areas. All grievances and land dispute were recorded, identified, and mapped in the Coupe Development Plan. There is no evidence that the company operated in the affected area without the consent of the community or before resolving the issues.

The company had a formal Standard Operating Procedure to address disputes and grievances from the community. The SOP was reviewed and approved by the Director of Gerak Saga Sdn. Bhd.
