Compliance is defined when the organization demonstrates that there is no non-compliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

## **Background Information:**

**Chuan Huan Trading Sdn. Bhd. (Chuan Huan Trading)** is, on and from 21/04/2015, incorporated under Companies Act 2016, and is registered in Kuala Lumpur, Malaysia, with registration #: 201501016026 (1141359-K). Chuan Huan Trading produces sawn timber and exports them to Sarawak, South Korea, Japan and Taiwan.

Bestearn Sdn. Bhd. is, on from 27/06/1989, incorporated under Companies Act 2016 and changed its name to Hap Seng Property Investment Sdn. Bhd. (Hap Seng Property Investment) with registration #: 198901006336 (183641-A).

Hap Seng Property Investment leased Sawmill B (Shed 37) Shed 62 and Shed 63, from 01/11/2023 to 31/10/2025 to Chuan Huan Trading for processing and storing of sawn timber.

Chuan Huan Trading has an agent, Arus Borneo Sdn. Bhd. to handle export documents.

**Chuan Huan Trading Sdn. Bhd.** has demonstrated compliance with the Sabah Standard Principles 5-6 for Chain of Custody and is recommended to receive a GFS Statement of Compliance and Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include:

**Gap 001/2024 (minor) – Checklist 5.1.6, 6.4.2:** Chuan Huan Trading Administration procedure needs to include legal compliance (permits, labour, environment, etc.) maintenance of records for raw material, production & sales / export based on TLAS status.

**Gap 002/2024 (minor) – Checklist 5.2.1, 6.1.1, 6.1.2, 6.1.3:** Chuan Huan Trading shall ensure the current system for purchasing and receiving is according to the COC procedure and maintain the Sales Contract in the office.

**Gap 003/2024 (minor) – Checklist 5.2.3, 5.2.4, 5.2.5:** SFD shall ensure the removal Pass is stamped as Sabah TLAS CC for suppliers compliant under Sabah TLAS P1-4.

**Gap 004/2024 (minor) – Checklist 5.2.7, 5.2.11, 5.2.12:** Chuan Huan Trading shall identify the Sabah TLAS status from receiving to the packaging.

Gap 005/2024 (minor) – Checklist 5.3.1, 5.3.2: Chuan Huan Trading should renew the JTK license annually, work permit for workers must be valid and all workers shall be registered under COI.

**Gap 006/2024 (minor) – Checklist 5.3.5:** All workers must register and contribute monthly EPF as stipulated in the EPF website, Chuan Huan Trading to submit JKKP 8 for 2023 annually by 30<sup>th</sup> January.

The next surveillance visit is scheduled for December 2025.
