# **Summary Information**

## **Overview of Licensee:**

In January 2011, K.K. Advantage Sdn. Bhd. (K.K. Advantage) entered into an agreement under the Agro-Forestry Management License Agreement, JP(SBN)04/2011(CO), made on 27/01/2022, with the State Government of Sabah to manage an area of approximately 500 ha, which is located in Bonggaya FR Class II, for the purpose of sustainable production of agroforestry crops and natural forest produce. However, the Chief Conservator of Forests (CCF) made decision that the licensed area herewith known as the "**conservation area**" is to be managed for conservation. This decision was made due to the fact that almost the entire parts of Bonggaya FR have been developed for agroforestry and Industrial Tree Plantation (ITP) and thus, have suffered loss of biodiversity.

The 500 ha is, therefore being devoted to conservation in order to protect the natural features of the Bonggaya Forest Reserve as a whole, providing public access for low-impact recreation and eco-tourism and environmental education. Because of this, K.K. Advantage in collaboration with the SFD carried out a detailed study and analysis of the conservation area and subsequently to prepare a Conservation Area Management Plan (CAMP) of which, this plan was prepared.

The plan builds on the principles of the initial CAMP (2014-2023), focusing on protecting the region's ecological integrity, including diverse flora and fauna, critical wildlife habitats and unique ecosystems, such as mangrove/Nipah forests. It addresses threats such as illegal logging, farming encroachments, and forest fires while ensuring community involvement and sustainable development for the nearby kg. Bukit Besi village.

In 2023, the SFD has decided to follow back the Forest Management Plan (FMP) format for all development plans; therefore, the 2<sup>nd</sup> FMP is to continue from the principles of the 1<sup>st</sup> CAMP to cover the next 10 years from 01/01/2024 to 31/12/2033.

## **Current Operations:**

Land use classification:

The licensed area is fully managed for conservation. Currently, KK Advantage only conducts patrolling and maintenance of license boundaries.

## **Environmental Context:**

Commercial exploitation in Bonggaya Forest Reserve (FMU 18) started in the 1950s. Based on records, four Special Licenses issued from 1971 to 1974 and at least seven Form 1 licenses issued from 1971 to 2001. The licensed area consists of Lowland Mixed Dipterocarp and Kerangas Forest, Seasonal (or Lowland) Freshwater Swamp Forest and Mangrove and Nipah Mixed Forest types. The forest has a greater mix of dipterocarp species, with the most dominant species being those from the subgenus Rubroshorea (Red seraya). Other very common and dominant dipterocarp species include *Parashorea spp.* and *Dryobalanops spp.* 

# FDS-TLAS-006

A team from the SFD Forest Research Centre (FRC) conducted a survey in June 2013. Based on the report, 18 plant species are classified as Borneo endemics, such as Kapur Paji (*Dryobalanops lanceolate*) and another 6 Sabah endemic species, such as *Gnetum leptostacyum*, whereas 10 other species are categorized as endangered, vulnerable and critically endangered according to the IUCN Red List (2013). The FRC team reported that the conservation area contains abundant wildlife including wild boar, monkeys such as Proboscis Monkey (*Nasalis larvatus*) and Long-tailed Macaque (*Macaca fascicularis*), wetlands birds along the riparian reserve of the Klagan River. There were 13 bird species observed in the licensed area, where one is endemic to Borneo, the White-crowned Shama (*Copsychus stricklandii*). An Environment Impact Assessment for the licensed area is not required as the area is to be managed for conservation and does not involve any harvesting or conversion of land [Refer Environmental Quality (Prescribed Activities) (Environmental Impact Assessment) Order, 1987 (Appendix 2)].

# Social Context:

There are no villages within the project area; however, KK Advantage identified 2 villages surrounding the licensed area, namely, Kg Biangkang, comprising not more than 20 houses situated upstream of the licensed area and Kg. Bukit Besi is approximately 2 KM from the licensed area that is only accessible through the river (Sg. Klagan). The nearest township is Beluran Township about 35 km south of the licensed area.

Based on the current draft 2<sup>nd</sup> FMP, KK Advantage plan to conduct a Social Baseline Survey (SBS) with the SFD Beluran. The element in this survey is to collect information regarding demographics, economic activities, and access to services such as education, healthcare and infrastructure. As of the assessment, KK Advantage has yet to conduct the social baseline survey. However, based on KK Advantage, Kg. Bukit Besi was established in the 1950s and occupied part of the FMU before it was gazetted. Approximately 80 ha of the licensed area was cultivated by the local community. Currently, KK Advantage is working closely with the Sabah Forestry Department and the community of Kg. Bukit Besi to monitor and patrol the licensed area to prevent encroachment.

## **Scope of Assessment**

- The scope of the evaluation is to verify compliance of KK Advantage Sdn. Bhd. with the Agro-Forest Management License Agreement [JP(SBN)04/2011(CO)] for FMU 18 (Partly).
- The assessment is in accordance with the terms of the agreement for the "Sabah Legality Standard Principles 1 4 dated 1 January 2024 (SFD-TLAS-006).
- Site evaluation to verify and report the level of compliance by KK Advantage Sdn. Bhd. and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not comply adequately with a criterion.

KK Advantage submitted the 2<sup>nd</sup> Forest Management Plan for its operation for the period of 2024 – 2033.

An Environment Impact Assessment for the licensed area is not required as the area is managed for conservation and does not involve any harvesting or conversion of forest areas [Refer Environmental Quality (Prescribed Activities) (Environmental Impact Assessment) Order, 1987 (Appendix 2)].

**Gap 005/2025 (minor) – Checklist 4.1.6:** K.K. Advantage shall document or establish any communications or consultations with the community associated with the licensed area.

The next annual surveillance audit will be scheduled for January 2026.
