Summary Information

Overview of Licensee:

- The State Government of Sabah declared this project area as the Tanah Rizab for all the communities in Kampung Ogan under Land Ordinance (Chapter.68) that was signed on 22/09/1986 in Kota Kinabalu, published under Government Gazette Number GN. 482/86. The area is located in the Beluran District, comprising a total area of 830 ha.
- On 02/09/2008, a Joint Venture agreement between Pemegang Amanah Tanah Rizab Kediaman Anak Negeri Kg. Ogan, Labuk Sugut, Beluran and Krismega Sdn. Bhd. (480733-A) was made. The agreement stated that all applications, payments, meetings and discussions related to the Form 1 timber license agreement are under the responsibility of Krismega Sdn. Bhd.
- Krismega Sdn. Bhd. has appointed Milik Ria Sdn. Bhd. (247568-T) to carry out logging activities. The previous Form 1 approval was valid from 20/11/2015 to 19/11/2017. No logging operation was conducted since the end of 2017.
- The Form 1 license was renewed and approved by SFD on 30/03/2022 and valid from 16/03/2022 to 15/03/2023 (Ref.#: JPHTN/BN700-2/3/2/11/44) to continue the remaining unlogged area.
- The main objective of this operation is to extract all merchantable logs available from the area for oil palm planting purposes.

Environmental Context:

- No evidence of an approved EIA for the 830ha project area.
- The project area is located on undulating terrain. The altitudes of the project area range from 30m to 450m above mean sea level (AMSL). The highest peak is situated at the southern boundary of the project site.
- Vegetation at the project site mostly comprises of shrubs, grasses and ferns in the development area and logged over forest of dipterocarp *Shorea spp*. and pioneer species in undeveloped areas.
- Class 1 Timimbang Forest Reserved area borders the project site.
- The nearest river, Sungai Sugut is located approximately 2 km from the boundary.

Social Context:

- The nearest human settlement Kampung Monopod is located 2 km from the project boundary.
- There is no NCR claim area inside the project area.

Scope of Assessment

- The scope of the evaluation is to verify compliance of **Pemegang Amanah Tanah Rizab Kediaman Anak Negeri Kg. Ogan, Labuk Sugut, Beluran** with the Form 1 license JP(SBN)008/2021(F1) for the area.
- The assessment is in accordance on the terms of the agreement for the "Sabah Legality Standard Principles 1 - 4 dated 01st January 2015 (SFD-TLAS-002).
- Site evaluation to verify and report the level of compliance by Pemegang Amanah Tanah Rizab Kediaman Anak Negeri Kg. Ogan, Labuk Sugut, Beluran and contractors to the standard in respect to each of the criteria within this report.

The Major Gap shall be addressed within 2 months by November 2022 and remains Outstanding. The licensee proposed an EIA to EPD, no assessment has been conducted by a registered EIA consultant to cover the entire project area.

Recommendations

Pemegang Amanah Tanah Rizab Kediaman Anak Negeri Kg. Ogan, Labuk Sugut, Beluran has not demonstrated compliance with the Sabah Legality Standard (**SFD-TLAS-002**) as non-compliance was identified under Criterion 1.2, thus is not eligible to receive a GFS Statement of Compliance and Sabah Timber Legality Assurance System Compliance Certificate (TLAS-CC) from SFD.

The Major Gap shall be addressed within two months by **November 2022**. **Gap 001/2022 (Major) Outstanding – Checklist 1.2.1:** Provide evidence of an approved Environmental Impact Assessment (EIA) for the entire project area.

Gap(s)/Observation(s) identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap(s)/observation(s) include: Gap 002/2022 (Minor) – Checklist 1.2.3, 2.1.11: Conduct ECR as required by EPD.

The next surveillance audit will be scheduled for September 2023.

End of Summary Report
