## **OBJECTIVES**:

- The objective of this checklist is to verify compliance to the Criteria listed in the Sabah Legality Standard as defined by Principles 1 4 for Sabah dated November 2020 (SFD-TLAS-002).
- Compliance is defined when all applicable criteria are observed to be compliant. A Minor Gap to any indicator does not constitute non-compliance to a criterion. A Major Gap to any applicable indicator does reflect non-compliance to a criterion. Compliance for a criterion where multiple minor gaps are identified in indicators under the criterion may reflect non-compliance to the criterion.
- All issues identified under this standard shall be considered appropriate to the scale and degree of forestry operations undertaken by the parties under the agreement.

## **Summary Information**

#### **Overview of Licensee:**

- Sabah Foundation or Yayasan Sabah (Yayasan Sabah) entered into an agreement (SFMLA: 09/97) with the State Government of Sabah on 10/09/1997 for 100 years to manage Commercial Class II Forest Reserves comprising 799,828 ha more or less.
- On 15/02/1999, a First Supplemental Agreement was made between the Chief Minister of the State of Sabah of the one part and Yayasan Sabah of the other part. In this First Supplemental Agreement, the licensed area was reduced by 200,000 ha from 799,828 to 599,828 ha.
- Between 2005 and 2018, another four (4) Supplemental Agreements were made between the Chief Minister's Office and Yayasan Sabah to excise several Class II licensed areas into Class I Protection Forest Reserves. Consequently, Yayasan Sabah's Class II licensed area was reduced from 599,828 ha to approximately 209,980 ha.
- In April 2019, another Supplemental Agreement to the Principal Agreement of SFMLA 09/97 was
  prepared for a project site of 30,000 ha located in Kalabakan Forest Reserve within FMU 25
  (partly). The concession area is under the jurisdiction of the Serudong District Forestry Office,
  with access via the Sapulut-Kalabakan Road.
- As of 2020, the total area under Yayasan Sabah management is approximately 239,980 ha, whereby commercial natural forest areas are managed under the subsidiary of Rakyat Berjaya Sdn. Bhd. (Rakyat Berjaya).
- An agreement was signed between Rakyat Berjaya and the appointed contractors [Aturmaju (Sabah) Holding Sdn. Bhd., Pelana Bumi Sdn. Bhd. and Prescott Hamilton Environmental Solutions Plt.] on 24/09/2020 to conduct Reduced Impact Logging (RIL) within the 30,000ha concession area.
- On 13/02/2024, a Power of Attorney was signed between Aturmaju (Sabah) Holding Sdn. Bhd. [Aturmaju (Sabah) Holding] and Majujuta Mewah Sdn. Bhd. (Majujuta Mewah), appointing Majujuta Mewah as the sole RIL logging contractor, responsible for timber sales, and payment of statutory charges to the government within coupe TWU 03/2021. Majujuta Mewah is affiliated with Megawakid Sdn. Bhd. and Cargo Timber Sdn. Bhd., which provide support for the company's management.
- The management of Pelana Bumi Sdn. Bhd. (Pelana Bumi) is associated with Hasil Bumimakmur Sdn. Bhd. and Hasil Baik Sdn. Bhd. Subsequently, on 26/03/2021, the agreement for subcontracting log extraction within coupe TWU 01/2022 was signed between B3 Timber Sdn. Bhd. and Pelana Bumi.
- Currently, Prescott Hamilton Environmental Solutions Plt. does not appoint any other subcontractor to conduct RIL harvesting within the project area. Teknikal Ukur Borneo was appointed to prepare the CHP and registered with the SFD.
- The previous assessment was conducted in June 2023 that resulted in 7 gap(s) and 1 observation(s) (Report #: GFSSBH003-191a).

#### **Current Operations:**

- The current harvesting area under Majujuta Mewah is Compartment 34 and 35.
- The current harvesting area under Pelana Bumi is Compartment 01 and 09.
- Prescott Hamilton Environmental Solutions Plt. has yet to commence the RIL harvesting within the project area.

## **Environmental Context:**

- Yayasan Sabah has 30,000 ha of Commercial Class II natural forest within Kalabakan Forest Reserve (part of FMU 25) for Natural Forest Management and Conservation managed under Rakyat Berjaya.
- Mengilan Forest Reserve and Sg. Anjeranjermut Forest Reserves are Class I protected reserves that border the project site.
- The project site consists of 5 types of forests: the Lowland Kerangas Forest, Upland Kerangas Forest, Lower Montane Kerangas Forest, Lowland Mixed Dipterocarp, and Upland Mixed Dipterocarp.
- The forest areas along Sg. Tambulanan is a wildlife corridor for large mammals such as elephants, 'Banteng' and others to move between northern Kalimantan and southern Sabah. The Orang Utan survey recorded a range of 1 to 30 nests/ha in some areas of the project site.
- There are two major rivers within the project site: Sg. Tambulanan and Sg. Luis, along with a tributary of Sg. Samantulang at the southwest section. Both Sg. Tambulanan and Sg. Luis is connected to Sg. Serudong at the southeast section.
- An Environmental Impact Assessment was conducted and approved by Environmental Protection Department (EPD) for the concession area.

Rakyat Berjaya Sdn. Bhd. has complied with the Sabah Legality Standard (SFD-TLAS-002) as no non-compliance was identified during the assessment on 22 – 26 April 2024.

#### Summary of status of operations by **Principle**:

#### Principle 1.

The FMP was approved by the Chief Conservator of Forests on 05/04/2021, which is valid from 01/01/2020 to 31/12/2030 for an area of 30, 000 ha at FMU 25 (partly) (Ref. #: JPHTN/SFM 900-1/1/42/62). The amendment was made as required by the SFD to revise the implementation schedule for CHP preparation and RIL harvesting due to the changes in the previous planning defined in the said FMP (Ref. # Amendment Slip No. 01/2022).

#### April 2022: Gap 001/2022 (minor) – Checklist 1.2.3

Lack of mitigation control was observed concerning waste segregation and oil spillage. Lack of fire extinguishers in the facilities.

#### April 2023: Gap 001/2022 (minor) – Outstanding

Inadequate and expired fire extinguishers in the facilities. No safety signage, first aid kit and a lack of mitigation controls for oil spillage at the workshop area.

**Observation 001-2024 - Checklist 1.8.2:** Rakyat Berjaya shall establish PSPs to measure harvesting impacts and monitor residual stand growth.
