### Terms of Assessment

The scope of the evaluation is to verify compliance of Everply Sdn. Compliance is defined when the organization demonstrates that there is no non-compliance to any applicable criteria. Non-compliance to the Sabah Legality Standard occurs when the organization does not comply with 1 or more criteria. Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

The information presented in this report is based on documentation and other information presented by the client and observations made during the field verification under the assessment. **Background Information:**

Everply Sdn. Bhd. (Everply) was incorporated in Miri, Malaysia, with registration #: 200901022381 (865479-D). Everply has a warehouse agreement between Tropical Timber & Trading (Sabah) Sdn. Bhd. from 01/04/2021 to 30/03/2024 for storing products. However, no imported materials were stored in the warehouse. The imported materials are directly shipped from the supplier to its buyer, Jang Heng Sdn. Bhd.

The previous assessment was conducted in April 2023 that resulted in 0 gap(s) and 0 observation(s) (Report #: GFSSBH 004-485).
